# Small window to safety

Thousands of Palestinians streamed onto Gaza's only highway on Friday, fleeing the combat zone in the north after Israel announced a window for safe passage, as officials in the enclave said the Palestinian death toll surpassed 11,000 people.

Amid an intensifying campaign of airstrikes and ground battles in Gaza City, the search for safety in the besieged enclave has grown increasingly desperate. Tens of thousands have walked south, where they face the prospect of ongoing bombardment and dire conditions. Others have crowded into and around hospitals, sleeping in operating rooms and wards.

Gaza medical officials accused Israel of striking near hospitals on Friday, though Israel said at least one was the result of a misfired Palestinian rocket. Gaza's largest city is the focus of Israel's campaign to crush Hamas following its deadly Oct. 7 surprise incursion.

Early Friday, Israel struck the courtyard and the obstetrics department of Shifa Hospital, where tens of thousands of people are sheltering, according to Ashraf al-Qidra, spokesperson at the Health Ministry in Hamasrun Gaza. A video at the scene recorded the sound of incoming fire waking people up in their makeshift shelters in the courtyard, followed by screams for an ambulance.

The Israeli army has alleged that Hamas hides in and under hospitals and that it has set up a command center under Shifa -

The director of Shifa said Israel demanded the facility be evacuated, but he said there was nowhere for such a large number of patients to go.

"Where are we going to evacuate them?" Director Mohammed Abu Selmia asked in an interview on the television network Al Jazeera. The Health Ministry

later said one person had been killed at Shifa and sevwere wounded. Another strike near the Al-Nasr Medical Center, which includes two hospitals for children, killed two people, according to the min-

In all, Gaza health officials said strikes were carried out near four hospitals overnight and early Friday.

US Secretary of State Antony Blinken said on Friday that "far too many" Palestinians have died and suffered and that while recent Israeli steps to try to minimize civilian harm are positive, they are not enough.

Though US President Joe Biden and others have challenged the figures from the Gaza Health Ministry as exaggerated, Assistant Secretary of State Barbara Leaf told American lawmakers this week that it was "very possible" the numbers were even higher than reported.

# **Putin visits** military HQ

Russian President Vladimir Putin visited the Southern Military District headquarters in Rostov-on-Don as he assessed the state of his country's forces in Ukraine as the war drags on toward winter. It was his second public visit to the headquarters in less than a month. Video shared by a Russian state news agency showed Putin being greeted late Thursday by Defence Minister Sergey Shoigu and Valery Gerasimov, chief of the General Staff. Almost 21 months of war have significantly eroded both Russia's and Ukraine's military resources. As winter comes, the fighting is likely to further settle into attritional warfare and analysts expect little change to the over 1,000km front line. In Rostov-on-Don, less than 100 km from Ukraine's southeastern border, Putin was "introduced to new types of military equipment" and was informed about the

progress of the war, his spokesperson Dmitry Peskov said, as per Russian state news agency Tass.

# The Philippines and China report new maritime confrontation



Chinese and Philippine vessels engaged in a new confrontation in the South China Sea on Friday, with Manila charging that a Chinese coast guard ship and accompanying vessels conducted dangerous maneuvers and blasted a Philippine supply ship with a water cannon in disputed waters.

China responded that it acted appropriately under maritime law to defend what it says is its territory.

The incident was the latest n a series of maritime confrontations between the two nations over territorial disputes that risk turning into more serious armed engagements. Tensions have risen recently as China has blockaded an isolated Philippine marine outpost on Second Thomas Shoal, also known as Ayungin Shoal. The marines are based on a rusted old warship that the Philippine navy grounded deliberately in 1999 to bolster its territorial claim.

Last month, a Chinese coast guard ship and an accompanying vessel rammed a Philippine coast guard ship and a military-run supply boat near the contested shoal, according to Philippine officials. China accused the Philippine vessels of trespassing in what it said were Chinese waters "without authorisation" despite repeated radio warnings.

A Philippine government task force dealing with the South China Sea said on Friday that vessels belonging to China's coast guard and its paramilitary Maritime Militia "recklessly harassed, blocked and executed dangerous maneuvers in another attempt to illegally impede or obstruct a routine resupply and rotation mission.

# Sunak under pressure to sack Suella

**London:** British Prime Minister Rishi Sunak is under pressure to sack his Home Secretary, Suella Braverman, as the row surrounding her controversial newspaper article attacking the Metropolitan Police over its handling of Israel-Hamas protests in London continues to gain momentum on Friday. While Sunak's official spokesperson has said that he has "full confidence" in the Home Secretary, they did confirm that the contents of 'The Times' Op-Ed did not have the full clearance of her boss.

# Canada probes 'threat' to Air India passengers

Canada has said it takes any "threat" to aviation "extremely seriously" and is investigating online warnings, days after a banned pro-Khalistani group warned Air India passengers against travelling on November 19. Founder of the outlawed Sikhs for Justice

(SFJ) Gurpatwant Singh Pannun recently released a video threatening passengers of Air India flights on November 19, the day the ICC World Cup final takes place in Ahmedabad. The Canadian government and the Royal

Canadian Mounted Police have confirmed they are investigating a possible terror threat. Federal Transportation Minister Pablo Rodriguez posted on social media on Thursday that the government is investigating the al-

leged threat with its security partners. 'Our government takes any threat to aviation extremely seriously. We are investigating recent threats circulating online closely and with our security partners. We will do every-

thing necessary to keep Canadians safe." The RCMP confirmed on Thursday that it is investigating but refused to comment further,

the Vancouver Sun newspaper reported. "The RCMP takes all threats to national security very seriously, including threats made online," said Marie-Eve Breton, a spokesperson for the national RCMP. On Thursday, India said it will continue to press foreign governments to deny space to such extremist elements. External Affairs Ministry Spokesperson Arindam Bagchi said New Delhi strongly condemns such terrorist threats

Palestinians stream out of combat zone in north Gaza

# **Small window to safety**

Thousands of Palestinians streamed onto Gaza's only highway on Friday, fleeing the combat zone in the north after Israel announced a window for safe passage, as officials in the enclave said the Palestinian death toll surpassed 11,000 people.

Amid an intensifying campaign of airstrikes and ground battles in Gaza City, the search for safety in the besieged enclave has grown increasingly desperate. Tens of thousands have walked south, where they face the prospect of ongoing bombardment and dire conditions. Others have crowded into and around hospitals, sleeping in operating rooms and

Gaza medical officials accused Israel of striking near hospitals on Friday, though Israel said at least one was the result of a misfired Palestinian rocket. Gaza's largest city is the focus of Israel's campaign to crush Hamas following its deadly Oct. 7 surprise incursion.

Early Friday, Israel struck the courtyard and the obstetrics department of Shifa Hospital, where tens of thousands of people are sheltering, according to Ashraf al-Qidra, spokesperson at the Health Ministry in Hamas-run Gaza. A video at the scene recorded the sound of incoming fire waking people up in their makeshift shelters in the courtyard, followed by screams for an ambulance.

The Israeli army has alleged that Hamas hides in and under hospitals and that it has set up a command center under Shifa - claims the militant group and hospital

# **Putin visits** military HQ

Russian President Vladimir Putin visited the Southern Military District headquarters in Rostov-on-Don as he assessed the state of his country's forces in Ukraine as the war drags on toward winter. It was his second public visit to the headquarters in less than a month.

Video shared by a Russian state news agency showed Putin being greeted late Thursday by Defence Minister Sergey Shoigu and Valery Gerasimov, chief of the General Staff. Almost 21 months of war have significantly eroded both Russia's and Ukraine's military resources. As winter comes, the fighting is likely to further settle into attritional warfare and analysts expect little change to

the over 1,000-km front line. In Rostov-on-Don, less than 100 km from Ukraine's southeastern border, Putin was "introduced to new types of military equipment" and was informed about the progress of the war, his spokesperson Dmitry Peskov said, as per Russian

state news agency Tass.

# **French President Macron** laments melting glaciers

French President Emmanuel Macron said on Friday that melting glaciers are an "unprecedented challenge for humanity" and urged world leaders to work together on halting the devastating effects of climate

change. Such a united effort is desperately needed, even though the war in Ukraine and the latest Israel-Hamas war are taking away much of the international focus and hamper global unity and cooperation, Macron said.

The French leader spoke at the Paris Peace Forum, an annual event involving governments, nongovernmental groups and others seeking dialogue around global problems such as climate change, children's exposure to online violence and threats to human rights.

The world, Macron said, is witnessing "the collapse of the cryosphere under the impact of climate change," re-



ferring to parts of the Earth where water is in solid form, including glaciers.

"The most immediate and visible effect is the melting of the ice caps ... it represents an unprecedented challenge for humanity," Macron said.

Melting ice surfaces worldwide have an impact on biodiversity, rising sea levels and coastlines, they contribute to scarcity of drinking water, migration, greater release of CO2 and risk of a new pandemic, he

"All these threats are real," Macron said and called for urgent cooperation.
