# 7. SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNTS FOR THE PERIOD ENDED ON 31<sup>ST</sup> MARCH, 2010.

#### 1. Significant Accounting Policies

i. Basis of Accounting

The accounts are prepared under historical cost convention on accrual basis.

ii. Dividend/Interest Income
