# Uddhav Thackeray says will quit as CM, but say it to my face

New Delhi, June 22

AS THE MAHARASHTRA political crisis continues to play out, with the Shiv Sena headed for a split and chief minister Uddhav Thackeray possibly losing majority, the Governor's powers under the Constitution to call for a floor test takes centre stage. Article 174(2)(b) of the Constitution gives power to the Governor to dissolve the Assembly on the aid and advice of the cabinet. However, the Governor can apply

his mind when the advice comes from a chief minister whose majority could be in doubt.

In 2020, the Supreme Court Shivraj Singh Chouhan & Ors Versus Speaker, Madhya Pradesh Legislative Assembly & Ors upheld the powers of the Speaker to call for a floor test if there is a prima facie view that the government has lost its majority. "The Governor is not denied of the power to order a floor test where on the basis of the material available to the Governor it becomes evident that the issue as to whether the

government commands the confidence of the House requires to be assessed on the basis of a floor test," a two-judge bench by justices DY Chandrachud and Hemant Gupta held.

Under Article 175(2) the Governor can summon the House and call for a floor test to prove whether the government has the

The Madhya Pradesh government was faced with a similar situation when MLAs in the Jyotiraditya Scindia camp had defected to the BJP and then Co-

gress CM Kamal Nath had asked the Governor to dissolve the Assembly. The Governor instead called for a floor test.

"The spectacle of rival political parties whisking away their political flock to safe destinations does little credit to the state of our democratic politics. It is an unfortunate reflection on

the confidence which political parties hold in their own constituents and a reflection of what happens in the real world of politics. Political bargaining,

or horse-trading, as we noticed, is now an oft repeated usage in legal precedents," Uddhav Thackeray, battling to save the Maha

Vikas Aghadi coalition government, said he is willing to resign if the MLAs and Sainiks tell him to his face that they do not want him to continue as CM.
