Global:

USA

• Initial jobless claims rose 8,000 to a seasonally adjusted 219,000 from a revised 211,000 for the week ended February 22, 2020, as per the US Labor Department.

<u>Japan</u>

- Unemployment rate rose to 2.4% in January 2020 from 2.2% recorded in December 2019 according to Japan's
 Ministry of Internal Affairs and Communications.
- Industrial production rose 0.8% (MoM) in January 2020, after rising 1.2% (MoM) in December 2019, as per
 the data released by Japan's Ministry of Internal Affairs and Communications.
- Retail sales fell 0.4% (YoY) in January 2020 following a 2.6% (YoY) fall in December 2019, as per the data released by Japan's Ministry of Internal Affairs and Communications.
- Final Jibun Bank/Markit Manufacturing Purchasing Managers' Index (PMI) fell to a seasonally adjusted 47.8
 in February 2020 from a reading of 48.8 in January 2020.

China

Caixin/Markit Manufacturing PMI came in at 40.3 in February 2020, down from January's reading of 51.1.

<u>India</u>

- Gross Domestic Product (GDP) slipped to 4.75% (QoQ) in Q3 2019-20 in comparison with 5.1% (QoQ) (revised from 4.5% (QoQ)) recorded in Q2 2019-20, as per the data released by National Statistical Office (NSO).
- IHS Markit Manufacturing PMI fell to 54.5 in February 2020 from a level of 55.3 in January 2020.


