#### Global:

### USA

- ISM Non-manufacturing Purchasing Managers (PMI) Index rose to 55 in December 2019 from November 2019 reading of 53.9.
- Initial jobless claims dropped to 214,000 for the week ended January 14 from previous week 223,000, as per the US Labor Department.
- Unemployment rate remained unchanged at 3.5% in December 2019, according to figures released by Bureau of Labour Statistics.

### UK

- Gross domestic product (GDP) fell 0.3% (MoM) in November 2019, from 0.1% (MoM) in October 2019, as per Office for National Statistics (ONS).
- Industrial Production decreased 1.6% (YoY) in November 2019, from 0.6% (YoY) in October 2019, as per ONS.

#### <u>Eurozone</u>

- Retail sales rose by 1% in November 2019, after falling 0.3% in October 2019, as per Eurostat.
- Unemployment rate remained unchanged at 7.5% in November 2019, its lowest level since July 2008, according to figures released by Eurostat.

### <u>Germany</u>

Industrial production rose 1.1% (MoM) in November 2019, after reporting a fall of 1% (MoM) in October 2019, as per Federal Statistics Office.

- Consumer Price index (CPI) stood at 4.5%(YoY) in December 2019, unchanged from November 2019, as per National Bureau of Statistics (NBS)
- Producer Price Index (PPI) dropped by 0.5% (YoY) in December 2019 after falling 1.4% in November 2019, as per National Bureau of Statistics (NBS).

## <u>Japan</u>

• Flash Jibun Bank Services PMI dropped to a level of 49.4 in December 2019, after recording 50.6 in November

2019, as per Markit Economics.

# <u>India</u>

- Index of Industrial Production (IIP) rose 1.8% (YoY) in November 2019 after falling 3.9% in October 2019.
- Manufacturing production rose 2.7% in November 2019, after falling 2.3% in October 2019.


