#### Global:

#### USA

- Consumer Price Index (CPI) edged up 0.1% (MoM) in June 2019 compared to a similar rise in May 2019, as per the US Labor Department.
- Initial claims for state unemployment benefits declined 13,000 to a seasonally adjusted 209,000 for the week ended July 6, 2019, the lowest level since April 2019, as per the US Labor Department.
- Producer Price Index (PPI) rose 1.7% (YoY) in June 2019, the smallest gain since January 2017, slowing from a 1.8% (YoY) rise in May 2019, as per the US Labor Department.

## <u>UK</u>

Gross Domestic Product (GDP) rose 0.3% (MoM) in May 2019 recovering from a fall of 0.4% (MoM) in April
 2019, as reported by Office for National Statistics (ONS).

#### Eurozone

Industrial production rose 0.9% (MoM) in May 2019 after dropping by 0.4% (MoM) in April 2019, according
to figures by Eurostat.

#### **Germany**

- Industrial production rose 0.3% (MoM) in May 2019, reversing a 2% (MoM) fall in April 2019, as reported by Destatis.
- CPI rose 0.3% (MoM) in June 2019 compared to a similar gain in May 2019, according to data published by Destatis.

### <u>Japan</u>

- PPI dropped 0.5% (MoM) in June 2019 after falling 0.1% (MoM) in May 2019, as reported by Bank of Japan.
- Final industrial production rose 2% (MoM) in May 2019 compared to an initial estimated rise of 2.3% (MoM), as per data from Japanese Ministry of Economy, Trade and Industry.



## <u>China</u>

- CPI rose 2.7% (YoY) in June 2019 compared to a similar gain in May 2019, as reported by National Bureau of Statistics (NBS).
- PPI showed no annual growth in June 2019 compared with a 0.6% (YoY) rise in May 2019, as reported by NBS.

#### India

- Index of Industrial Production (IIP) expanded at a slower pace of 3.1% (YoY) in May 2019 compared to a rise of 4.3% (YoY) in April 2019, data released by Indian Ministry of Statistics and Programme Implementation.
- Wholesale Price Index (WPI)-based inflation declined to its 23-month low of 2.02% in June 2019 as compared to 2.45% in May 2019, according data released by Indian Ministry of Commerce and Industry.


