Global:

USA

- Retail sales rose 0.4% (MoM) in June 2019 compared to a similar gain reported in May 2019, as per figures by the US Commerce Department.
- Industrial production was flat in June 2019 compared to the rise of 0.4% (MoM) reported in May 2019, as per figures by the US Federal Reserve.
- Initial jobless claims rose by 8,000 to a seasonally adjusted 216,000 in the week ended July 13, 2019, as reported by the US Labor Department.

UK

- Unemployment rate remained unchanged at 3.8% in three months to May 2019, as per data from Office for National Statistics (ONS).
- Consumer Price Index (CPI) rose 2% (YoY) in June 2019 compared to the same rate of inflation as in May 2019, as per data from ONS.
- Producer Price Index (PPI output inflation) rose 1.6% (YoY) in June 2019, below the rise of 1.9% (YoY) registered in May 2019, as per data from ONS.
- Retail sales rose 3.8% (YoY) in June 2019, up from the 2.2% (YoY) rise reported in May 2019, according to data by ONS.

Eurozone

• CPI rose 0.2% (MoM) in June 2019 after registering a rise of 0.1% (MoM) in May 2019, according to data published by Eurostat.

Germany

• PPI fell 0.4% (MoM) in June 2019, below the drop of 0.1% (MoM) reported in May 2019, as per data released by Destatis.

<u>Japan</u>

• CPI growth was unchanged at 0.7% (YoY) in June 2019, according to Japan's Ministry of Internal Affairs and Communications.
