IHS Markit India Manufacturing PMI fell to 56.3 in November from 58.9 in October

Nikkei/IHS Markit Services PMI fell to 53.7 in November from October's 54.1

Reserve Bank of India held its benchmark repo rate at 4%. The reverse repo rate stood at 3.35%.

Macro Developments - Global

Final Jibun Bank Japan Services rose slightly to 47.8 from October's reading of 47.7

The Caixin/Markit Services PMI for China rose to 57.8 in November from October's 56.8

The seasonally adjusted unemployment rate for Germany fell to 6.1% in November from 6.2% recorded in October, as per the BA federal labour agency

Germany's Retail sales rose 2.6% (MoM)in October, reversing a 1.9% (MoM) drop in September, as per tha data by Destatis

IHS Markit Manufacturing PMI for Eurozone rose to 53.8 in November from October's 53.6

Eurozone's Retail sales rose 1.5% (MoM) in October following 1.7% (MoM) fall in September

USA's Initial claims for state unemployment benefits dropped 75,000 to a seasonally adjusted 712,000 for the week ended Nov. 28 as per the Labor department

USA's Unemployment rate fell to 6.7% in November from 6.9% registered in October

HS Markit/CIPS UK services PMI fell to 47.6 in November from 51.4 in October.
