CPI came in at 6.26% in June as compared to 6.30% recorded in the month of May as per the data released by the Ministry of Statistics & Programme Implementation (MoSPI)

WPI eased down to 12.07% in June from 12.94% in May as per the data released by the Ministry of Statistics & Programme Implementation (MoSPI)

Industrial production grew 29.3% (YoY) in May as per the National Statistical Office

Macro Developments - Global

China's GDP rose 1.3% (QoQ) in the second quarter of 2021, faster than the 0.6% (QoQ) growth recorded in the first quarter of 2021 as per the National Bureau of Statistics

China's Industrial production grew 8.3%(YoY) in June ,after a 8.8% (YoY) rise in May as per the National Bureau of Statistics

China Retail Sales rose 12.1% (YoY) in June after a 12.4% (YoY) rise in May as per the National Bureau of Statistics

Eurozone's Industrial Production fell 1% (MoM) in May after a 0.6% (MoM) rise seen in April as per the Eurostat

UK's CPI rose by 2.4% (YoY) in June 2021, up from 2.1% (YoY) rise in May as per the data from ONS

UK's Unemployment rate fell to 4.8% in the three months to the end of May, down from 5.0% in the three months to February aas per the ONS

USA's CPI rose 0.9% (MoM) in June, up from a 0.6% (MoM) rise in May

USA's Industrial Production slowed down to 0.4% (MoM) In June after a 0.7% (MoM) rise in May as per the Federal Reserve

USA's retail sales rose 0.6% (MoM) in June after falling 1.7% (MoM) in May as per the Commerce Department

Number of Americans applying for unemployment benefits with states fell by 26,000 last week to 360,000, as per the Labor department
