Germany's Manufacturing PMI rose to 66.6 in March from 60.7 recorded in February

Germany's Services PMI rose to 50.8 in March from 45.7 February

Germany's GfK Consumer Confidence Climate Index rose to -6.2 in April from -12.7 in March

Eurozone's Manufacturing PMI rose to 62.4 in March from 57.9 in February

Eurozone's Services PMI rose to 48.8 in March from 45.7 in February

UK's Unemployment rate fell to 5% in the three months to January from 5.1% in the last quarter of 2020

UK's CPI rose by 0.4% (YoY) in February, down from 0.7% (YoY) rise in January 2021

IHS Markit/CIPS UK Manufacturing PMI rose to 57.9 in March from 55.1 in February

UK retail sales rose 2.1% in February in comparison with the 8.2% fall seen in January. On a YoY basis retail sales were down by 3.7% in February

IHS Markit's fash U.S. Manufacturing PMI rose to 59 in March from 58.6 in February

US initial jobless claims slid to 684,000 in the week ended March 20th, a decrease of 97,000 from the previous weeks revised level of 781,000as per the Labor Department
