Japan's Retail sales rose 5.2% (YoY) in March as per the government data

Japan's Unemployment Rate fell to 2.6% in March from 2.9% in February as per the the Ministry of Communications and Internal Affairs

The final au Jibun Bank Japan Manufacturing PMI for Japan rose to 53.6 in April from 52.7 in March

China's Manufacturing PMI fell slightly to 51.1 in April from 51.9 in March as per the National Bureau of Statistics

GfK Consumer Confidence Index for Germany fell to -8.8 in May from -6.1 in April

Germany's Unemployment rate remained unchanged at 4.5% in March as per the Destatis

USA's GDP expanded 6.4% (QoQ) in first Qarter of 2021 following a 4.3% (QoQ) growth seen in fourth quarter of 2020 as per the preliminary estimates of the Commerce Department

Initial claims in regular state programs decreased by 13,000 to 553,000 in the week ended April 24 as per the Labor Department
