Macro Developments - Global

Japan's GDP contracted 3% (YoY) in July-September quarter following a revised rise of 1.5% in the previous quarter as per data released by the Cabinet Office.
On a OoO basis the GDP shrank 0.8%

China's Retail Sales grew 4.9% (YoY) in October after a 4.4% (YoY) rise in September as per the the National Bureau of Statistics (NBS)

China's Industrial production rose 3.5% (YoY) in October after a rise of 3.1% (YoY) in September as per the the National Bureau of Statistics (NBS)

Eurozone's Industrial production fell 0.2% (MoM) in September after a revise fall of 1.7% (MoM) in August as per Eurostat

UK's GDP expanded by 1.3% (QoQ) in the July-September quarter following a 5.5% (QoQ) growth seen in th previous quarter as per the Office for National Statistics

UK's Industrail Production advanced 2.9% (YoY) in September after a rise of 3.7% (YoY) in prevoius month as per Office for National Statistics

USA's CPI rose 0.9% (MoM) in October after a 0.4% (MoM) gain in September as per the Bureau of Labor Statistics. On a YoY basis the CPI rose 6.2% in October

Initial claims for state unemployment benefits fell 4,000 to a seasonally adjusted 267,000 for the week ended Nov. 6 as per the Labor Department
