## Macro Developments - India

India's CPI eased to 4.35% (YoY) in September 2021 in comparison to 5.30% (YoY) in the August

India's Industrial Production rose to 11.9% (YoY) in August 2021 in comparison to a contraction of 7.1% (YoY) witnessed in the same month a year ago as per the Ministry of Statistics & Programme Implementation

India's WPI eased down to 10.66% (YoY)(p) in September 2021 from 11.39% (YoY) in August

Macro Developments - Global

China's CPI rose 0.7% (YoY) in September after a 0.8% (YoY) rise seen in August as per the National Bureau of Statistics (NBS)

China's GDP grew 4.9% (YoY) in July-September quarter of 2021, down from the 7.9% (YoY) growth seen in the second quarter as per the NBS

China's Industrial Production grew 3.1% (YoY) in September after a 5.3% (YoY) rise seen in August as per the NBS

China's Retail Sales grew 4.4% (YoY) in September up from 2.5% (YoY) rise in August

UK's GDP grew 0.4% (MoM) in August after a revised fall of -0.1% (MoM) recorded in July as per the Office for National Statistics (ONS)

UK's Industrial Production rose 0.8% (MoM) in August after a 0.3% (MoM) rise in July as per ONS

USA's CPI rose 0.4% (MoM) in September after a 0.3% (MoM) rise in August as per the Labor Department

USA's Retail Sales rose 0.7% (MoM) in September after a 0.9% (MoM) rise in August as per the U.S. Commerce Department

US initial unemployment claims in regular state programs totaled 293,000 in the week ended Oct. 9 as per Labor department
