3. DETAILS OF THE OFFER

3.1 Background of the Offer

3.1.1 This Offer is being made to acquire substantial shares and control over the Target Company in terms of the provisions of Regulations 3(1) & 4 of SEBI (SAST) Regulations, 2011.

3.1.2 The Acquirer has entered into the SPA with the selling shareholder, on September 29, 2022, for the acquisition of 16,000 (Sixteen Thousand) Equity Shares representing 6.43% of the paid-up and voting equity share capital of Target Company at a price of Rs. 10.00/- (Rupees Ten only) per Equity Share aggregating to Rs. 1,60,000/- (One lakhs Sixty Thousand Only), payable in cash along with the acquisition of control over the Target Company. The Acquirer has also entered into a Share Purchase Agreement with the Non-Promoter Sellers with an intent to purchase 48,350 (Forty-Eight Thousand Three Hundred and Fifty) Equity Shares, representing 19.43% (Nineteen Point Forty-Three Percent) of the Voting Share Capital of the Target Company at a price of Rs. 10.00/- (Rupees Ten Only) per Sale Share aggregating to an amount of Rs. 4,83,500/- (Rupees Four Lakh Eighty-Three Thousand Five Hundred Only), payable through banking channels subject to such terms and conditions as mentioned in the Share Purchase Agreements with the Non-Promoter Sellers.

3.1.5 The prime objective of the Acquirer for this Open Offer is the substantial acquisition of Equity Shares and voting rights and control over the management and affairs of the Target Company.

3.1.6 The Offer is not as a result of global acquisition resulting in the indirect acquisition of the Target Company.

3.1.7 The salient features of the Share Purchase Agreements are as follows:

3.2.3 The Acquirer have made this Open Offer in terms of SEBI (SAST) Regulations, 2011 to the Public Shareholders of Target Company to acquire up to 64,688 (Sixty Four Thousand Six Hundred and Eighty Eight) fully paid up Equity Shares of Rs. 10.00/- (Rupees Ten only) each representing 26.00% of the paid-up share capital in accordance with Regulation 9(1)(a) of the SEBI (SAST) Regulations, 2011.

3.2.4 As on date of this Letter of Offer, the Target Company doesn't have:

- Any partly paid-up shares in the Target Company.
- Outstanding instruments in warrants or options or fully or partly convertible debentures/preference shares/ employee stock options etc., which are convertible into Equity Shares at a later stage.

- 4.1.4 Acquirer does not hold directorship in any company, including the Target Company.
- 4.1.5 Acquirer does not hold any Equity Shares of the Target Company and has not acquired any equity share of the Target Company during the 12 (Twelve) months period prior to the Public Announcement.
- 4.1.6 The Net worth of the Acquirer as on March 31, 2021, is Rs. 3,09,83,000/- (Rupees Three Crore and Ninety Eight Lakhs Eighty-Three Thousand Only) and the same is certified by Twinkal Jain, Chartered Accountant, partner of NGST & Associates, having its office at B/203, Borivali Paras CHS, Rokadia Lane, Nr. Gokul Hotel, Borivali (W), Mumbai - 400092 (Membership No.: 156938) vide her certificate dated 20/08/2022.

5. DECLARATIONS BY ACQUIRER

- 5.1 The Acquirer has confirmed that they are not categorized as a "Willful Defaulter" or a "Fraudulent Borrower" in terms of Regulation 2 (1)(ze) of the SEBI (SAST) Regulations, 2011. He has further confirmed that they and other companies, in which they are promoters and/or directors, are not appearing in the willful defaulter's list of the Reserve Bank of India.

- 6.3 The Target Company is engaged in the business as merchants, packers, traders, commission agents, business agents, selling agents, brokers, adatas, buyers, seller, indentors, importers, exporters, dealers in, commodities, mineral, ores, raw materials, manufactured products, goods and ware, plant, Machinery, spares, accessories, tools wool, raw silk, yarn fibers, garments, apparels, handlooms, cottage industries, poultry and dairy milk products, tobacco, leather wares, timber products, rubber and rubber products, plastics and plastic products, paper and paper products, electronic, steel and steel products, furniture, hardware, building construction materials, dyes, chemicals, petrochemicals, products, fertilizers, colours, paints glass and glassware ceramics, electrical items, household appliances, office equipments, stationeries, automobiles products, gold, silver, diamonds, precious stones and jewelers and to act as Export House.

- 7.1.4 There have been no corporate actions in the Target Company warranting adjustment of relevant price parameters under Regulation 8(9) of the SEBI (SAST) Regulations, 2011.

- i. CKYC form of KARTA including FATCA, IPV, OSV if applicable
- ii. KRA form

9.4 Procedure for tendering Equity Shares held in dematerialized form

- 9.4.7 For custodian participant, orders for demat Equity Shares early pay-in is mandatory prior to confirmation of order by the custodian. The custodians shall either confirm or reject orders not later than 6:00 PM on the last day of the Tendering Period. Thereafter, all unconfirmed orders shall be deemed to be rejected.

- 9.5.4 After placement of order, as mentioned in paragraph 9.5.3, the Selling Broker / eligible Public Shareholder must ensure delivery of the Form of Acceptance-cum-Acknowledgement, TRS, original share certificate(s), valid share transfer form(s) and other required documents either by registered post or courier or hand delivery to the Registrar to the Offer (at the address mentioned on the cover page not later than 2 (Two) days from the Offer Closing Date (by 5 PM). The envelope should be super scribed as "Limited Open Offer". One copy of the TRS will be retained by the Registrar to the Offer and it will provide acknowledgement of the same to the Selling Broker.
- 9.5.5 Public Shareholders holding physical Equity Shares should note that physical Equity Shares will not be accepted unless the complete set of documents is submitted. Acceptance of the physical Equity Shares by the Acquirer shall be subject to verification as per SEBI (SAST) Regulations, 2011 and any further directions issued in this regard. 9.7.3 The Letter of Offer will be dispatched to all the Public Shareholders of the Target Company, whose names appear on the register of members of the Target Company on the Identified Date.

9.7.4 In case of non-receipt of the Letter of Offer, such Public Shareholders of the Target Company may download the same from the SEBI website i.e. www.sebi.gov.in or obtain a copy of the same from the Registrar to the Offer on providing suitable documentary evidence of holding of the Equity Shares of the Target Company.

9.8 Settlement Process

9.8.1 On closure of the Offer, reconciliation for acceptances shall be conducted by the Manager to the Offer and the Registrar to the Offer and the final list of accepted Equity Shares tendered in this Offer shall be provided to the designated stock exchanges to facilitate settlement on the basis of Equity Shares transferred to the Clearing Corporation.

9.8.2 The settlement of trades shall be carried out in the manner similar to settlement of trades in the acquisition Window Circulars.

9.8.3 For Equity Shares accepted under the Offer, the Eligible Shareholders will receive funds payout directly in their respective bank accounts (in case of demat Equity Shares, in the bank accounts which are linked to the respective demat accounts) / as per secondary market pay-out mechanism (in case of physical Equity Shares). 9.8.12 In case of partial or non-acceptance of orders, the balance demat Equity Shares shall be returned directly to the demat accounts of the public shareholders. However, in the event of any rejection of transfer to the demat account of the public shareholder for any reason, the demat Equity Shares shall be released to the securities pool account of their respective selling broker and the selling broker will thereafter transfer the balance Equity Shares to the respective Public Shareholders.

9.8.16 In case of delay in receipt of any statutory approval(s), SEBI has the power to grant extension of time to Acquirer for payment of consideration to the Public Shareholders of the Target Company who have accepted the Offer within such period, subject to Acquirer agreeing to pay interest for the delayed period if directed by SEBI in terms of Regulation 18(11) of the SEBI (SAST) Regulations, 2011.

Note on taxation

Tax deduction at source
