Sub.: Your Letter No. L/SURV/ONL/PV/SS/2019-2020/51 dated August 14, 2019 seeking clarification regarding significant increase in the volume of our security across Exchanges, in the recent past.

This has reference to your captioned letter.

Since our last disclosure made on May 23, 2019 informing about the Share Purchase Agreement executed amongst Nippon Life Insurance Company ("Nippon"), Reliance Capital Limited ("RCL") and Reliance Nippon Life Asset Management Limited ("Company") on May 23, 2019 ("Agreement") and the details in connection with the Agreement, there have been no further disclosures under Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("Listing Regulations") required to be made by us.

It was also disclosed in the aforementioned disclosure that Nippon shall make an open offer for acquisition of shares from the public shareholders of the Company, in accordance with the relevant provisions of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("Open Offer"). All the required disclosures pertaining to the open offer have been duly made by the Manager to the Offer on behalf of Nippon.

It was also disclosed in the aforementioned disclosure that RCL was entitled to sell 10.76% (ten point seven six percent) of its shareholding in the Company by way of a SEBI prescribed method for the purpose of enabling the Company to meet with minimum public shareholding ("MPS") requirements. All the required disclosures pertaining to the Offer for Sale have been duly made by RCL.

We would like to inform that to the best of the information available with Company; we do not have any further information/announcements to share with the Stock Exchanges under Regulation 30 of the Listing Regulations which have a bearing on the price/volume behavior of our scrip traded.



We hereby confirm that we are in full compliance with respect to mandatory disclosures under Regulation 30 of the Listing Regulations.
