Reply: - There is no such circulated information for the general consumption/information of MTNL except that deliberations through Committee of Secretaries meetings are being held at highest level of Department of Telecommunications (DoT) and other Govt. Ministries for various options on way forward in case of MTNL and for further action for formal approvals of Government thereto. Therefore, no such specific decision or information is available at this point of time. As such there is no such circulated / written information that can be disclosed under Regulation 30 of the SEBI (LODR) Regulations, 2015 with MTNL.

- Whether company are aware of any information that has not been announced to the Exchanges under regulation 30 of the SEBI (LODR) Regulations, 2015.
