Sub: **Notice for Making Payment of Outstanding Stamp Duty on Client and Proprietary Trades in West Bengal**

Further to notice bearing no.CLS/WB/CSE/855/109 dated 08/11/2016, you are now requested to make payment of all dues on account of Stamp duty in respect of **Client Trade @ 0.01%** for Delivery Trade and @ 0.002% for Non-delivery w.e.f.01-04-2014, if not already cleared till date. All payments of arrears of stamp duty on this account from 01-04-2014 to 28-02-2017 shall be paid through GRIPS only. Payment of stamp duty in respect of **Client Trade** from 01-03-2017 being current payment shall be made through BOISL, as usual.

You are also requested to make payment of all dues on account of Stamp duty in respect of **Proprietary Trade @0.002%** w.e.f.01-04-2016 till 06-03-2017 subject to a maximum of Rs. 1500/- per day per member taking aggregate value of Proprietary transactions in all segments each day. Payments of arrears of stamp duty on this account from 01-04-2016 to 28-02-2017 shall be paid through GRIPS only. Payment of stamp duty in respect of **Proprietary Trade** w.e.f.01-03-2017 being current payment shall be made through BOISL, as usual.

With effect from 07-03-2017, Stamp duty on account of **Proprietary Trade** shall be payable @ 0.001% subject to a maximum of Rs. 1500/- per day per member taking aggregate value of Proprietary transactions in all segments each day.

You are advised to start process of making payments with immediate effect so that you may clear your bulk dues within **March 2017** itself and all outstanding amount shall be cleared by 31-05-2017 without fail.
