Members would require communicating their assent or dissent through remote e-voting system only. All the Members are hereby informed that:

- The special businesses as set out in the Postal Ballot Notice will be transacted through remote e-voting only.
- A person whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories/KFinTech as on the cut-off date, i.e., Friday, November 1, 2024 only shall be entitled to avail the facility of remote e-voting. Once the vote on the resolution is cast by the Member, he/she shall not be allowed to change it subsequently or cast the vote again.
- The remote e-voting period commences on **Friday, November 15, 2024 at 9:00 A.M. IST** and ends on **Saturday, December 14, 2024 at 5:00 P.M. IST**. During this period, Members holding shares as on cut-off date, may cast their vote electronically. Any postal ballot received from the member beyond the said date will not be valid and voting by electronic means shall not be allowed beyond the said date.
