The Company has sent the Notice convening EOGM through electronic mode on July 8, 2024, containing procedure and manner of e-voting, to those Members whose e-mail addresses are registered with the Company and/or Depository Participant(s) as on the cut off date i.e. Friday, July 5, 2024. Pursuant to the provisions of Section 101, 108 of the Companies Act, 2013 ("Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), and the Circulars issued from time to time, the Members are provided with the facility to cast their votes on all the resolutions as set forth in the Notice convening EOGM using electronic voting system ("e-voting") provided by CDSL. Chhattisgarh 9 July 2007
On 9 July 2007, troops of 55 Battalion of CRPF launched an operation against Maoists in the forest near Urpelmeta village, PS-Eraboro, Dantewada district. Initially, no contact was made. As the troops were withdrawing, around 400 Maoists ambushed them with heavy fire. The troops retaliated vigorously, forcing the Maoists to withdraw. As the troops advanced, the Maoists attacked again from two directions, attempting to encircle them. A fierce four-hour gunfight ensued, resulting in significant losses on both sides. CRPF neutralized around 50 Maoist members, while 15 brave troopers made the ultimate sacrifice in the line of duty. The nation will forever remain indebted to them and their families.
CENTRAL RESERVE POLICE FORCE Assam 9 July 2008
On 9 July 2008, troops of 189 Battalion of CRPF were on a Road Sanitization Patrol on NH-A1, PS-Maibong, North Cachar Hills, when insurgents ambushed them with indiscriminate fire. The troops quickly took positions and retaliated. Using tactics of fire and move, they counter-attacked with mortar and rifle grenades, advancing towards the insurgents' positions. Seeing the daring advance, the insurgents began to flee. Shaheed Constable D.K. Mandal, spotting the fleeing insurgents, came out of cover and chased them. Unfortunately, he was hit by bullets fired by the insurgents and attained martyrdom on the battlefield.
