Sub: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the Company has received an Order dated July 11, 2024 from Deputy Commissioner of State Tax, Mumbai on July 12, 2024 at 11:30 a.m. under Section 16, 73, 155 and 50 of Central Goods and Service Tax Act/Maharashtra Goods and Service Tax Act. The Order stipulates for Tax liability amounting to Rs 61,76,399, Interest of Rs 57,84,451 and a Penalty of Rs 6,17,641 aggregating to a demand of Rs 1,25,78,491. The said demand pertains to GST Audit conducted by GST Department, Maharashtra for the period 2019 - 2020.

Based on our assessment, we believe that the aforementioned demand is not maintainable and the Company is in the process of preferring appeal against the said Order. The said Order has no material impact on the financials, operations or other activities of the Company.

The detailed disclosure with respect to the Order as required under the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as 'Annexure – I'.
