The total envisaged cost of the projects financed by banks/financial Institutions (FIs) reached a new high of ₹3.91 lakh crore during 2023-24, with 54 per cent planned to be invested by the year-end, according to an article in RBI's latest monthly bulletin.

During 2023- 24, about 944 projects got assistance from banks/FIs with a record high total cost of projects of ₹3,90,978 crore, as compared to 547 projects

sanctioned during the previous year having total cost of ₹2,66,546 crore, per the article "Private Corporate Investment: Growth in 2023-24 and Outlook for 2024-25" authored by RBI officials Kamal Gupta, Rajesh B Kavediya, Sukti Khandekar and Snigdha Yogindran.

PROJECT PIPELINE

The phasing profile of the pipeline projects finance suggests that the envisaged capex will increase significantly to ₹2.45 lakh crore in 2024-25 from ₹1.59 lakh crore in 2023-24, the offi-



cials said. They observed that rising domestic demand and capacity utilisation, improved profitability of corporates, sustained credit demand, business optimism and government's thrust on infrastructure development, along with policy measure to encourage investment activities, bode well for private capital investment.

Private sector lender RBL Bank witnessed higher credit card bad loans sequentially in Q1FY25. This was mainly on account of stress in the lower-ticket size card business - on which the RBI had hiked risk weights last vear — and due to the bank completely moving its collection operations in-house from an external business partner, according to R Subramaniakumar, MD and CEO, RBL Bank. Edited excerpts from an interview with *businessline*:

We undertook this exercise in March-April and have now completed the transition. This caused some disruption as people had to be recruited, get realigned on field level, etc.

This is, however, a one-off event. In the last quarter we had said that low-ticket segment in credit cards is not showing good signs of performance, and that continued to be the trend. If I remove the one-off transition event and absorb low ticket size stress, the credit card business is on track.





DSP Pensions, a recent entrant to the pension fund management industry, plans to diversify into NPS distribution and will apply for a point of presence (PoP) licence with the regulator by the end of this year, its Chief Executive Officer, Rahul Bhagat has said.

"We are in the process and geared up to apply. It will be done in the near future. We are aiming to secure the licence before this year end," Bhagat told businessline when asked about plans to become a PoP for NPS.

A PoP is the first point of contact for the National Pension System (NPS) account holders.

Bhagat said that he was very positive about the pensions industry and had big plans to position DSP as a significant player in this space, not just as the 11th player. "We want to get into distribution," he added.

Argentina will be facilitating easy imports of Indian pharmaceuticals with flexible norms.



As part of the measures, if the Indian laboratory has a relevant certification of



DSP Pensions, a recent entrant to the pension fund management industry, plans to diversify into NPS distribution and will apply for a point of presence (PoP) licence with the regulator by the end of this year, its Chief Executive Officer, Rahul Bhagat has said.

"We are in the process and geared up to apply. It will be done in the near future. We are aiming to secure the licence before this year end," Bhagat told businessline when asked about plans to become a PoP for NPS.

A PoP is the first point of contact for the National Pension System (NPS) account holders.

Bhagat said that he was very positive about the pensions industry and had big plans to position DSP as a significant player in this space, not just as the 11th player. "We want to get into distribution," he added.
