SECOND CORRIGENDUM TO THE NOTICE OF EXTRAORDINARY GENERAL MEETING OF THE SHAREHOLDERS OF NIRAJ CEMENT STRUCTURALS LIMITED

This second corrigendum is issued in continuation of the Notice dated 17th September 2024 and 18th September, 2024 for the Extraordinary General Meeting ("EGM") of Niraj Cement Structurals Limited ("the Company"), scheduled to be held on Thursday, October 10, 2024, at 11:00 A.M. (IST) via Video Conferencing (VC)/Other Audio Visual Means (OAVM). The Notice was duly dispatched to the shareholders in compliance with the Companies Act, 2013 and the relevant rules thereunder. Except for the changes outlined below, all other contents of the original Notice remain unchanged.

The Company had applied to BSE Limited ("BSE") and the National Stock Exchange of India Limited ("NSE") for in-principle approval regarding the proposed preferential issue of Equity Shares and Convertible Warrants, for which shareholder approval is being sought. Following observations from BSE and NSE, the Company has made amendments to the Notice, as described below:

- 1. **Point No. 01 of Item No. 02 and Item No. 03**: To provide more clarity on the objectives of the proposed issue, Point No. 1 of Item No. 02 and Item No. 03 of the Explanatory Statement have been revised. The updated details are included in the revised Notice and Explanatory Statement dated October 04, 2024, enclosed herewith.
- 2. **Point No. 02 of Item No. 03**: The date of the Board meeting was incorrectly mentioned as September 10, 2024, instead of the correct date, September 13, 2024. This has been corrected in the revised Notice.
- 3. **Point No. 03 of Item No. 02 and Item No. 03**: Clarifications have been made regarding the determination of the issue price under Regulations 164 and 165 of the SEBI ICDR Regulations. The relevant sections of Point No. 3 in Item No. 02 and Item No. 03 have been updated in the revised Notice.
- 4. **Point No. 07 of Item No. 02 and Item No. 03**: Certain inadvertent typographical errors related to the intention/contribution of promoters, directors, key managerial personnel, and senior management to subscribe to the offer have been corrected in the revised Notice.



- 5. <u>Annexure B of the Explanatory Statement</u>: The name of the Ultimate Beneficial Owner (UBO) of certain investors was inadvertently omitted and has now been included in the revised Notice.
- 6. <u>Pre-Preferential Holdings of Proposed Allottees</u>: Certain proposed allottees were found to have pre-preferential holdings, which were not mentioned in the earlier notice. This has now been corrected and included in the revised Notice.
- 7. **Disqualification of Proposed Allottees**: It was identified that certain proposed allottees of Equity Shares under the Preferential Issue were disqualified due to violations of Regulation 159 and other applicable provisions of Chapter V of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations"). As a result, the Preferential Committee of the Board of Directors, using the powers delegated to it by the Board in its meeting on September 13, 2024, has proposed to replace these allottees with new investors, as described in the revised Notice.
