Dear Sir / Madam,

I, am writing this letter to inform you of my intention to be reclassified from Promoter and Promoter Group category in accordance with regulation 31 A of the SEBI LODR Regulations. I am disclosed as a promoter of Vikas Ecotech limited ("Company") in the shareholding pattern filed by the Company with the BSE Limited & NSE ("BSE" & "NSE"), in accordance with the SEBI LODR Regulations. As on date, I am holding 18,500 equity shares of the Company.

Further, as on today, I am not, directly or indirectly, associated with the business of the Company and do not have any influence over the business and policy decisions made by the Company. Further, I am not involved in the day to day activities of the Company nor am I exercising any control over the affairs of the Company nor I have any special rights in the Company through formal or informal arrangements including through any shareholder agreement. Accordingly, I wish to reclassify myself from the 'promoter' category to 'public' category.

In connection with application for reclassification, I hereby confirm and certify that:

1. I along with persons related to me together:
  - a. do not hold more than ten percent of the total voting rights in the company.
  - b. do not exercise control over the affairs of the company, directly or indirectly.
  - c. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements.
  - d. are not being represented on the board of directors (including not having a nominee director) of the Company.
  - e. do not act as a key managerial person of the Company
  - f. are not 'wilful defaulter(s)' as per the Reserve Bank of India Guidelines
  - g. are not fugitive economic offender
2. There is no pending regulatory action against me.

3. I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 at all times from the date of re-classification, failing which, I shall be reclassified as promoter/person belonging to the promoter group of the company.
