The Board at the same meeting shall also consider a proposal for declaration of 'Interim Dividend' to the Equity Shareholders in terms of Regulation 29(1)(e) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Interim dividend, if declared, by the Board, the record date pursuant to Regulation 42 of the SEBI Regulations will be Friday, November 29, 2024 for the purpose of ascertaining the eligibility of the shareholders for payment of Interim Dividend for the FY 2024-25.

Further, in continuation to our letter dated September 25, 2024, regarding closure of trading window for the aforesaid purpose, the 'Trading Window' for trading in Company's securities, will continue to remain closed until expiry of 48 hours after the Un-Audited Standalone & Consolidated Financial Results for the quarter & half year ended September 30, 2024 are submitted to Stock Exchanges in terms of Company's "Code of Conduct" to Regulate, Monitor and Report trading by Designated persons."
