The Maharashtra State Road Transport Corporation (MSRTC) will procure 5,000 new buses annually as part of a comprehensive five-year plan aimed at modernising its fleet

and improving services.

The plan, which includes phasing out old buses, marks a significant shift in the state's public transport strategy. State transport minister Pratap Sarnaik, on Friday, said that no buses would be hired on a ren-tal basis in the future, as

fleet.
Chairing the meeting, which included MSRTC's vicechairman and MD Dr Madhav Kusekar, Sarnaik stressed the need for a comprehensive need for a comprehensive strategy to accommodate elec-tric buses and set up charging stations at all depots. Squabble with help: Employer cleared of SC/ST Act charges
