## Subject: <u>Scrutinizer Report on Postal Ballot Result conducted as per the relevant</u> provisions of the Companies Act, 2013

I, Arunesh Kumar Dubey, FCS, Proprietor, Arunesh Dubey & Co., Company Secretaries, New Delhi was appointed as Scrutinizer by the Board of Directors of the Company at its meeting held on Friday, May 24<sup>th</sup>, 2024 for the purpose of scrutinizing the Postal Ballot Voting conducted by remote e-voting process in a fair and transparent manner and for the purpose of ascertaining the requisite majority on the postal ballot carried out in accordance with the provisions of Sections 108 and 110 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") (including any statutory modification(s), clarification(s), substitution(s) or re-enactment(s) thereof for the time being in force) and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations"), Secretarial Standards-2 (SS-2) on General Meetings Issued by the Institute of Company Secretaries of India and in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for conducting postal ballot process through e-voting vide General Circulars Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, 03/2022 dated May 5, 2022 and 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023 ("MCA Circulars"), and any other applicable laws and regulations, for seeking approval of shareholders of KAMA Holdings Limited ("the Company") by way of a special resolution (as indicated) for matter(s) as considered in the Resolution in Postal Ballot Notice dated May 24, 2024through Postal Ballot ("Postal Ballot").



The Company has availed E-voting facility from National Securities Depository Limited (NSDL)for conducting e-voting by members of the Company. As per MCA Circulars and applicable provisions of the Act, Postal Ballot notices were sent to all shareholders through e-mail. The e-voting portal remained open for voting from Monday, May 27, 2024 (9.00 A.M. IST) to Tuesday, June 25, 2024 (5.00 P.M. IST) both days inclusive. The shareholders of the Company holding shares as on the cut-off Date i.e. Friday, May 17, 2024 were entitled to vote on the resolution.

A public notice in newspaper informing the members about dispatch of postal ballot notice and commencement of E-voting were given on May 25, 2024. Members have been informed that those shareholders who were members of the Company as on cut-off date i.e. Friday, May 17, 2024 can download the postal ballot notice from the website of the Company or website of NSDL.

The shareholders were required to cast their votes online through remote e-voting on or before 5.00 PM of Tuesday, June 25, 2024.

Further, I would also like to mention that Shareholders who have split their votes into "Assent" as well as "Dissent" in respect of each DP ID/Client ID or Folio No., while their votes are taken as cast, they have been counted only once for the purpose of their presence, which has been mentioned under the head" Assent".

After the closure of the voting, the votes cast under remote e-voting facility were unblocked in the presence of Mr. Ankit Kaushik & Ms. Shikha Garg who are not in employment with the Company on 5.00 P.M on June 25, 2024.

The electronic registers/reports and all other papers and relevant documents relating to the Postal Ballot, shall remain in our safe custody until the Chairman approves and signs the minutes of the aforesaid meeting and the same would thereafter be handed over for safe keeping to Mrs. Ekta Maheshwari, Whole Time Director, CFO & Company Secretary of the Company.

As per Section 110(2) of the Companies Act, 2013 read with Secretarial Standards on General Meeting (SS-2) issued by the Institute of Company Secretaries of India, if a resolution is assented to by a requisite majority of the shareholders by means of Postal Ballot, it shall be deemed to have been duly passed on the last date specified fore-voting i.e. June 25, 2024.



I hav eon the reckoning of voting rights of the shareholders on the basis of paid-up value of the shares registered in their names; found that the resolution has been passed with requisite majority. You may accordingly declare the results of voting by postal Ballot through remote e-voting.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, Rules thereunder read with relevant MCA Circulars, Secretarial Standards on General Meetings (SS-2) and Regulations contained in the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through electronic means on the resolution contained in the Postal Ballot Notice. Our responsibility as a scrutiniser for the Postal Ballot is restricted to the extent of preparation and presentation of Scrutiniser's Report of the votes cast "FOR" or "AGAINST" the resolution stated in the Postal Ballot Notice, based on the reports generated from the e-voting systems provided by the NSDL, the authorized agency to provide e-voting facilities results of Postal Ballot which forms part of this report and are attached as Annexure-A and based on these reports, I report that Item no.1 of the Postal Ballot Notice stand passed with the requisite majority.
