HIMACHAL FINANCIAL CRISIS: CM Sukhu says state's financial situation grim

Ministers to forgo salary for 2 mnths

Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu announced Thursday that he, his ministers, chief parliamentary secretaries and chairpersons and vice-chairpersons of boards and corporations would defer drawing their salaries and allowances for two months, citing the state's "grim financial situation".

The chief minister made the announcement in the assembly and also urged other members of the House to follow suit.

He said the government was making efforts to increase its revenue and reduce unproductive expenditure but it would take some time for the results to be visible.

Expressing concern over the dismal financial position of the state, Sukhu said the

Revenue Deficit Grant (RDG) for the year 2023-24 was Rs 8,058 crore, which has been reduced by Rs 1,800 crore to Rs 6,258 crore during the current financial year.

"In 2025-26, the revenue deficit grant will be reduced by another Rs 3,000 crore to a mere Rs 3,257 crore, which will make it even tougher for us to meet our needs," he added.

Sukhu said no grants have

been released against the Rs 9,042 crore Post-Disaster Need Assessment (PDNA) from the Centre for damage to roads, bridges and infrastructure during 2023 monsoon.

He added that Rs 9,200 crore deducted from the employees under the National Pension Scheme (NPS) has also not been refunded so far by the Centre despite repeated pleas of the state government.

Revanth Reddy's brother gets notice for illegal construction

Amid an ongoing drive against illegal encroachments on lakes and other government properties here, authorities have slapped a notice on Telangana Chief Minister A Revanth Reddy's brother and several others for alleged construction of unauthorised structures.

Tirupati Reddy told reporters on Thursday that he received a notice for constructing his house in the Buffer Zone of a water body.

He said the property was purchased after getting the documents verified by a lawyer. Moreover, the previous owner had obtained the relevant permissions for construction of the house.

No official has contacted me in this regard, he added. Tirupati Reddy assured full cooperation with the officials if they propose to initiate action for the alleged violations.

SC raps T'gana CM over remarks on Kavitha's bail

The Supreme Court on Thursday took strong objection to Telangana Chief Minister A Revanth Reddy's comments related to the bail granted to BRS leader K Kavitha in cases linked to the alleged Delhi excise policy scam.

HC dismisses DA case against Shivakumar

Asks etitioners to seek relief in SC

FP Bureau BENGALURU

Stating that only the Supreme Court is competent to decide on Centre-State disputes, the Division Bench of the Karnataka High Court on Thursday dismissed a bunch of pleas challenging the State government's decision to withdraw its consent for a probe by the Central Bureau of Investigation (CBI) against Deputy Chief Minister DK Shivakumar.

In November, 2023, the Cabinet decided to withdraw the decision of the previous BJP government giving consent for investigating a disproportionate assets case against Shivakumar in 2020 for accumulating disproportionate

assets (DA) between 2013 and 2018.

After this, the case was referred to Karnataka Lokayukta early February this year. Following this, the Lokayukta registered a case against the Deputy CM.

He appeared before the investigating agency a week ago.

The decision of the Cabinet to withdraw the CBI probe was challenged by BJP MLA Basanagouda Patil Yatnal and the CBI.

The Bench comprising Justices K Somashekhar and Umesh M Adiga dismissed petitions filed by the CBI and Yatnal stating that their petitions are not maintainable as only the Supreme Court was competent to deal with the Centre and State relations as per Article 131 of the Constitution.
