Over 2.29 lakh students from pvt joined govt schools this year: State govt

EXPRESS NEWS SERVICE AHMEDABAD, AUGUST 12

MORE THAN two lakh students from private schools have switched to government schools in Gujarat in the current academic year, the state government stated Monday.

Among municipal corporations, the Ahmedabad Municipal Corporation, at 37,785, saw the highest number of students leaving private schools to enroll in government ones. This is followed by 22,892 students in Surat Municipal Corporation, 10,602 students in Vadodra Municipal Corporation, and 6,204 in Rajkot Municipal Corporation.

Among districts, Banaskantha saw the highest with 10,228 students switching to government schools, followed by Mehsana (8,267), Bhavnagar (8,242), Junagadh (7,892), Anand (7,769), Ahmedabad Rural (6,510), 6,881 students each in Rajkot and Gandhinagar, Kutch (5,952), Kheda (5,910), and Surat (5,777).

In total, 2.29 lakh students from Balvatika (pre-primary) to Class 12 enrolled in government schools in the academic session 2024-25, the government stated.

It added that the government has progressively increased the budget every year in the interest of the students in the education sector. "A total of Rs 55,114 crore has been provided by the state government for education with an increase of Rs 11,463 crore compared to the budget provision of the previous year 2023-24," the statement read.

The government added that over one lakh smart classes have been functional in the year, more than 5,000 are under progress to enable students to access technological education.

POLITICAL ROW OVER TRIBAL TWIN MURDERS Kin distance from 'prayer meet'; families threatened, alleges AAP

A POLITICAL storm kicked off in Narmada district after the fathers of the two tribal twin brothers who were allegedly beaten to death last week at an upcoming tribal museum near the Statue of Unity in Ekta Nagar Monday distanced themselves from a 'homage (shradddhanj) event planned by INDIA bloc on Tuesday.

While Aam Aadmi Party (AAP) Dedapada MLA Chaitar Vasava, who has announced the prayer meet, stated that the 'silent' event will be attended by leaders across political spectrum, including the BJP, leaders from the saffron party denied the claims. Meanwhile, the AAP alleged that the victim families were "misled" and "threatened to believe that their government compensation will be taken back if they do not attend the event."

On Monday, in separate videos, the fathers of the victims — Jayesh Tadi and Sanjay Tadi — stated that the families would "not be responsible" for any law and order situation that arises at the meet. "As per rituals, we cannot leave the house for a month and a half after the death of our son. The shradddhanj meeting has not been organised by us and we cannot go to the meeting... We are not responsible for (law and order) due to this meeting... Those who want to offer their shradddhanj can come to our house, our doors are open 24x7. Jayesh's father, Sanjay Tadi, said in the video.

In a similar video, Sanjay's father Gajendra, said, "Our family is not involved in the programme that has been organised at Kevadia. If any casualty or untoward incident occurs on this

programme, it is not our responsibility," following the videos. Chaitar Vasava, who had exhorted the tribal community members to join in huge numbers, said Tuesday's event was apolitical and would be attended by all tribal leaders, including those from the BJP.

"The event being held in Kevadia is a silent event; there will be no public address. Moreover, it is an event to offer respects to the departed souls and all tribal leaders, including Congress' Anant Patel, BJP MPs Mansukh Vasava (Bharuch) and Jashu Rathva (Chhotu Ldepur) will also be present. Bharatiya Adhivi Party (BAP) leaders and Chhotu Vasava will also attend the event," he stated.

The Dedapada MLA also met Narmada Superintendent of Police Prashant Sumbhe to seek permission for the event. Until Monday evening, the police did not issue any permission to the AAP to organise the event.

Later Monday, the party issued a statement saying the families of the deceased have been "misled" to make the video messages. "On Monday that the victims had succumbed to their injuries, Dedapada MLA Chaitar Vasava as well as BJP Nandod MLA Darshana Deshmukh, along with BJP District Chief Ghanshyam Patel and other BJP leaders, had unanimously decided to hold this silent homage programme for the deceased on August 13, The Narmada SP had also given an assurance that the event can be organised with permissions... However, the families have been threatened to believe that their government compensation will be taken back if they attend the event; we have no personal agenda in this," the AAP stated.

Retiring Chaitar's statement, the party said the event was to be a "silent meet, without sloganeering," and would be held as per the plan as "no one should object" to paying tributes.

However, an elected BJP representative, under whose jurisdiction Kevadia falls, denied that

any "joint decision" was held with AAP to organise a prayer meeting. "Ever since the incident, we have been visiting the families daily to share their sorrow. We have not decided to hold any joint prayer meeting with Chaitar Vasava or the INDIA bloc. The government has extended compensation and the police have taken action. The BJP is not part of any other event," the leader said.

Bharuch MP Mansukh Vasava, who had visited the families along with Cabinet Minister Kuber Dindor on Saturday, accused Chaitar of "playing politics". "I am not aware of any BJP event to pay homage to the two men. It has been announced by the AAP and Congress from Day One. Chaitar Vasava is used to speaking lies to gain political benefit," Mansukh said.

"If Chaitar has claimed that Nandod MLA Darshana Deshmukh is attending the event, it is between them. It is out of the question that I will attend Chaitar's event," he said.

Dalit activists to distribute 5K rakhis to protest SC sub-quota judgment

A GROUP of Dalit activists under the aegis of Anant Bahao Andolan Samiti (ABAS) will distribute 5,000 rakhis among women to protest against the recent Supreme Court judgment on sub-classification of reservation within various Scheduled Caste communities, said a Samiti member on Monday.

On August 1, a seven-judge bench of the Supreme Court had given a majority ruling (6:1) holding that the Scheduled Castes do not constitute a socially homogenous class and can be sub-classified by the states to provide reservation to the less

privileged among them. The ABAS has also announced a Maha Sammelan in Ahmedabad on August 18 against the SC ruling.

Activist and ABAS member Raju Solanki said, "We are opposing this judgment. The sub-classification of reservation is unnecessary and can cause class struggle within Dalits. Reservation is the only lifeline of Dalits and tinkering with it can

cause damage to the community. It has already been damaged by the 10% EWS reservation."

"We are demanding to bring the reservation policy within the 9th Schedule of the Constitution and make it immune to judicial review," Solanki said.

"We are going to distribute the rakhis ahead of Rakshabandhan among women as they are emotionally connected to the festival and we want them to join the protest by safeguarding their brothers to safeguard the reservation," Solanki added.

"We will buy 5,000 rakhis and distribute them along with a pamphlet while visiting women door-to-door," he added.

Bribery charges: Railway official gets 3 yrs in jail

A SPECIAL CBI court in Gandhinagar has sentenced a senior assistant financial advisor (construction) of Western Railway to three years of rigorous imprisonment and slapped a penalty of Rs 75,000 for accepting Rs 20,000 bribe in 2008.

The case was registered on March 10, 2008 accusing Vidhya Sagar Acharya of demanding undue advantage from a complainant for clearing his bills for the works carried out by him.

Acharya was arrested the following day for demanding and accepting a bribe of Rs 20,000. The CBI filed the charge sheet on April 29, 2009 against the accused for accepting bribe and criminal misconduct. He was found guilty during the trial.
