MORE THAN two lakh students

from private scrools have switched to government schools in Gujarat in the current aca-demic year, the state govern-ment stated Monday. Among municipal corpora-tions, the Ahmedbad Municipal Corporation, at 37,786, saw the highest number of students leav-ing private schools to enroll in zov-

Cojouranon, a 13/203, sew tuch highest number of students leaving highest number of students leaving reading mixed schoolsteering linguistics. This is followed by 22,892 students in Surat Municipal Corporation, 10,602 students in Vadodara Municipal Corporation, and 6,204 in Rajkov Municipal Corporation. Among districts, Banaskantha saw the highest with 10,228 students switching to government schools, followed by Mehsana (3,267), Bhavnagar (8,242), Junagadh'(7,892), Anand (7,259), Almandabar Rural (6,910), 6,881 students each in Rajlot and Gandhinagar, Kutch (5,952), Kheda (5,910), and Surat (5,777). In total, 2.29 lakh students from Balvatika (pre-primary) to Class 12 enrolled in government schools in the academic session 2024-25, the government stated. It added that the government has progressively increased the budget every year in the interest of the students in the education sector. "Atotal of Rs 55.114 crore has been provided by the state sector. "Atotal of RS 55,114 crore has been provided by the state government for education with an increase of Rs 11,463 crore compared to the budget provi-sion of the previous year 2023-24," the statement read.
