- iii. Date and time of end of "Remote e-voting": Sunday, 29th September, 2024 at 5:00 P.M.(same day)
- iv. Cut-off date for E-Voting: Monday, 23rd day of September, 2024
- v. Remote E-voting shall not be allowed beyond 5:00 P.M. on Sunday, 29th September, 2024.
- vi. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 23rd day of September, 2024, may obtain the login ID and password by sending a request at <a href="helpdesk.evoting@cdslindia.com">helpdesk.evoting@cdslindia.com</a> or thiraniprojects@gmail.com. However, if you are already registered with CDSL for remote e-voting then you can use your existing user ID and password for casting your vote. - vii. The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
