The Scheme became effective on April 01, 2024, upon filing of the Certified Copy of the NCLT Order sanctioing the Scheme, by all the Companies, with the Registrar of Companies, Ahmedabad. These Financial Results have been prepared after giving effect of the Scheme w.e.f. April 01, 2022 i.e. Appointed Date. Accordingly, this Financial Results comprise of Financial Information for the Residual Undertaking of the Demerged Company.
