Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you of a significant development concerning the matter of **Protean eGov Technologies Limited (formerly known as NSDL E-Governance Infrastructure Limited) vs. Alankit Limited & Another**. This matter was adjudicated under Commercial Arbitration Petition Nos. 462 of 2022, 351 of 2024, and 32 of 2024, filed under Section 9 of the Arbitration and Conciliation Act, 1996.

Following the arbitral award, the parties have successfully reached a settlement. The total claim raised by the Company was for ₹68.5 Crores. This has been settled for a sum of ₹38.06 Crores, consisting of:

- ₹28.54 Crores offset as a counterclaim, and
- ₹9.52 Crores received from Protean eGov Technologies Limited post-settlement of the counterclaim.

This resolution underscores the Company's unwavering commitment to protecting its financial and operational interests. The receipt of this substantial settlement amount is expected to significantly strengthen the Company's financial position, reflecting positively on its overall business standing.

We believe this development constitutes a material event and warrants disclosure to all stakeholders, in adherence to applicable regulatory requirements.

We request you to take this information on record and ensure its dissemination to all concerned stakeholders.
