Sub: Change in Directorate - cessation of directorship of Shri Subodh Kumar Singh as Government Director on the Board.

Ministry of Steel, Government of India vide email dated 23<sup>rd</sup> December 2024 has communicated that in pursuance of Department of Personnel and Training's communication no. 36/02/2024-EO(SM-I) dated 17.12.2024, Shri Subodh Kumar Singh, IAS (CG:97), is relieved of his duties in the Ministry of Steel (MoS) w.e.f. afternoon of 18<sup>th</sup> December, 2024, consequent upon approval of Competent Authority for his repatriation to his parent cadre i.e. Government of Chhattisgarh.

Further, vide Order dated 22<sup>nd</sup> October 2024, MoS had clarified that a Government Nominee Director on the Board of Steel CPSE shall cease to hold his/her position on the Board of a CPSE immediately upon his/her transfer, retirement, resignation or upon his name being struck of the roll of the Ministry, as the case may be.

Accordingly, in view of the said Order dated 22<sup>nd</sup> October 2024 read with earlier Order dated 20<sup>th</sup> March, 2023 of Ministry of Steel, Government of India, Shri Subodh Kumar Singh (DIN: 01863607) has ceased to be the Government Director on the Board of NMDC Steel Limited w.e.f. 18<sup>th</sup> December 2024 (AN).
