HP govt proposes amendment to Town & Country Planning act

Shimla, Sept 2 (UNI) To enhance construction regulations, the Himachal Pradesh government introduced a bill in the state assembly on Monday, proposing amendments to the Himachal Pradesh Town and Country Planning (TCP) Act, 1977. The amendment aims to extend the jurisdiction of the TCP Department to include plots of 1000 square meters or more outside the existing TCP and Municipal Corporation (MC) limits, mandating design approval for such constructions.

The amendment bill, tabled by TCP Minister Rajesh Dharmani during the post-lunch session of the assembly, seeks to address the recurring incidents of landslides and building collapses, which have caused substantial loss of life and property during the monsoon seasons of 2023 and 2024.

The widespread devastation, attributed to erosion from flooding and unstable construction practices, has underscored the need for stricter building regulations in the state.

Under the current provisions of the Himachal Pradesh Town and Country Planning Act, 1977, the TCP Department's regulatory oversight is limited to notified planning areas and special areas, with a focus on plots larger than 2500 square meters.

This restriction has left numerous constructions outside these areas vulnerable to inadequate planning and structural instability.

The proposed amendment aims to reduce the threshold from 2500 square meters to 1000 square meters, thereby bringing a broader range of constructions under regulatory scrutiny.

Electricity supply to public Ganesh Mandals at household rates

Kalyan/Bhandup, Sept 2: "Public Ganesh Mandals are provided with temporary and immediate electricity connection facility from Mahavitaran. Domestic electricity tariff will be charged for this connection. However, Mahavitaran has appealed that the public Ganesh Mandals should take advantage of this facility and use electricity only by having an official electricity connection.

Registration certificate for temporary electricity connection to Ganesh Mandals, Mandap permission from local self-government body, Police station license, Electricity inspector's certificate that power supply is safe, power demand application, power supply layout test report and nationalized bank account passbook shadowed copy etc.

Documents are required. Ganesh Mandals should contact the nearest Mahavitaran office with necessary documents. "

In order to avoid any kind of electrical accident during the Ganeshotsav period, during the construction of pavilions, lighting and scenery, low pressure and high pressure electrical lines, distribution boxes etc. Keep a safe distance from the system. Electrical safety rules should be strictly followed while arranging the electrical system in the mandap. The electrical system arrangement in the mandap should be taken from approved electrical contractors.

Ganesh Mandals should not compromise on electrical safety measures. The mobile numbers of the Branch Engineers of Mahavitaran in the working area should be recorded in case of emergency. Maximum 10 vehicles in election campaigns: Haryana CEO

Chandigarh, Sep 2 (UNI) Haryana Chief Electoral Officer (CEO), Pankaj Agarwal on Monday said that with the commencement of the nomination process for the 2024 Assembly elections, candidates and political parties must adhere to the guidelines issued by the Election Commission of India (ECI) during roadshows and election rallies to avoid causing inconvenience to the public.

He said any candidate or political party must obtain permission for the use of vehicles in the election campaign; vehicles cannot be used for campaigning without this permit. He further shared that it is also necessary for candidates or political parties to submit the details of the vehicles registered for campaigning to the Expenditure Observer so that these expenses can be included in their election expenditure.

Besides this, any deployment of extra vehicles can only occur if prior notification is given by the candidate or their agent well before the actual deployment of vehicles.

When providing the details of vehicles used for election campaigns, it is important to specify the areas and tehsils where these vehicles will be operating, said Agarwal.

He shared that the use of vehicles for campaigning must comply with traffic regulations. He further stated that, except for security vehicles, no convoy with more than 10 vehicles will be allowed.

Agarwal said that all bigger convoys shall be broken up, and such broken up convoys must have a distance of at least 100 meters between them. He said that the use of loudspeakers on public platforms or vehicles during election campaigns will be prohibited from 10 PM to 6 AM.
