Details of the violation(s)/contravention(s) committed or alleged to be committed;	The European (EU) Commission post a detailed investigation has proposed a levy of provisional Anti-Dumping duty of 11.4% on the exports of OFC from STL and STCSL, India. It is important to clarify that this is a provisional levy, which will be followed by a thorough consultation and review process. The Commission will consider the submissions, oral and written, made in response to the Provisional disclosure before issuing a final disclosure by September, 2024 and thereafter, a final determination will be issued in January, 2025. STL believes that it has a very good case on merits. There are several manifest errors in the provisional disclosure, which STL is confident would be addressed by the Commission in its Final disclosure likely to be issued in September, 2024.

Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	As it is a provisional levy of duty of 11.4%, the financial impact will be determined only after release of final levy notification of the anti-dumping duty for export of Optical Fibre Cable from STL & STCSL.
