Summary of 13th round of e-auction held on 31st May 2024 in the Liquidation process of C and C Constructions Limited

The 13th round of E-auction was held on 30th and 31st May 2024 for the following Blocks of Assets of C and C Constructions Limited:

- 1- Block 1 Sale of Corporate Debtor as a Going Concern (including takeover of live BGs) at INR 135 crores.
- 2- Block 2- Sale of Land and Building at Plot no. 70 sector 32, Gurugram along with Land and Structures at Kathua and Zirakpur and Plant and Machinery at INR 50 crores.
- 3- Block 3- Sale of Investments of Corporate Debtor at INR 30 crores.
