Huge Win for Treesa & Gayatri, Sindhu Loses

PV Sindhu suffered yet another setback against Carolina Marin, but the rising Indian women's doubles pair of Treesa Jolly and Gayatri Gopichand stunned world number two Baek Ha Na and Lee So Hee of South Korea to enter the quarterfinals at Singapore Open on Thursday. Sindhu blew away 18-15 lead in the decider to go down to Marin in a thrilling 21-13, 11-21, 20-22 women's singles last-16 match. It was Sindhu's sixth loss on the trot against her arch-rival dating back from 2018. But the Commonwealth Games bronze medalist duo of Treesa and Gayatri kept the Indian flag flying by eliminating Baek and Lee 21-9 14-21 21-15 in close to one-hour battle. **PTI**

GOLDEN BALL AUCTION Maradona's Heirs Lose Court Battle

A French court ruled that the auction of a trophy awarded to the late Diego Maradona after the 1986 World Cup can go as planned despite opposition from his heirs, their lawyer told AP on Thursday. Lawyer Gilles Moreu told The AP the court's ruling "was not favourable to the heirs of Diego Maradona." The trophy is set to be auctioned next Thursday in Paris by the Aguttes auction house. Moreu said the president of the Nanterre court outside Paris considered the current owner of the trophy, identified as Bencheieb, "should be considered as acting in good faith." **PTI**

Red Bull Buys Small Stake in Leeds United

Red Bull have bought a minority stake in English football club Leeds United in a deal that will also see the energy drink company become the team's shirt sponsor next season. The club announced on Thursday a "multi-year agreement" with Red Bull, whose other football interests include owning Leipzig in Germany and having a longstanding association with Salzburg in Austria. Leeds missed out on a PL return for next season by losing to Southampton on Sunday. "The ambition to bring Leeds back to the PL and establish themselves in the best football league in the world fits very well with Red Bull," said Oliver Mintzloff, CEO of Red Bull corporate projects and investments. **AP**

'Classical' Pragg Tames Carlsen

Grandmaster sole leader after Rd 3 with win over World No 1 at home; sister Vaishali tops women's competition

Indian Grandmaster R Praggnanandhaa crushed world number one Magnus Carlsen for the first time in Classical format to emerge as the sole leader in the Norway chess tournament Stavanger. Having beaten him a few times in online and faster versions of the game and after losing to him in the finale of the last World Cup, Praggnanandhaa finally got past the home favourite in what would be known as a clear classical triumph.

Following the third-round win, the 18-year-old Indian now leads the men's section with 5.5 points in all, half a point clear of USA's Fabiano Caruana who scored his first victory in classical against reigning world champion Ding Liren of China.

Carlsen, on three points, looked like a distant third but with each classical win worth three points, this might not hold for too long.

Hikaru Nakamura of United States, Firoozja Alireza of France and Liren are all joint fourth currently on 2.5 points in the six-player double round-robin contest.

"I wish Magnus would take similar risks against us old folks," said Nakamura on Carlsen's choice of playing a risky battle against Praggnanandhaa.

In the women's event, Praggnanandhaa's elder sister R Vaishali maintained her sole lead after getting past Anna Muzychuk of Norway in the Armageddon game after drawing the Classical.

Vaishali inched up to 5.5 points too and enjoyed a full-point lead over women's world champion Wenjun Ju of China who is sole second by a half point margin over compatriot Tingjie Lei. It was a Sicilian Kann, an opening that does not find many favours in the elite chess circles, wherein Praggnanandhaa got an advantage through better space control

The middle game saw Magnus' king stuck in the centre and the Indian super-talent capitalised with some deft manoeuvres after the minor pieces were off the board.

Eventually, the King's vulnerability came to question as Praggnanandhaa posed some dangerous checkmate threats. The game lasted just 37 moves. **PTI**

Too Easy for Sabalenka, Djokovic

Roland Garros bans alcohol in stands to keep unruly fans in check on another rain-marred day

Aryna Sabalenka and Novak Djokovic soared into the third round of the French Open on Thursday as tournament organisers stepped up their fight against unruly fans by announcing an alcohol ban in the stands while also dealing with the wet-weather backlog.

Playing under the roof on Court Philippe Chatrier even

as Roland Garros officials were scratching their heads over what to do with the schedule after a fifth straight rain-hit day, second seed Sabalenka blew away qualifier Moyuka Uchijima 6-2, 6-2. "That's the little advantage we get as top players because we play in big stadiums with the roof," Sabalenka said. "So I knew that no matter

what the weather is, I'm going to play. That's really helpful."

Defending champion Djokovic then outclassed Spaniard Roberto Carballes Baena 6-4, 6-1, 6-2, while seeds Alexander Zverev, Daniil Medvedev, Elena Rybakina and Elina Svitolina all went through unaffected by conditions due to overhead cover.

Meanwhile, Marketa Vondrousova overcame American Katie Volynets 0-6, 6-1, 6-4 while 11th seed Danielle Collins fell to Serbian qualifier Olga Danilovic 6-7(3) 7-5 6-4 after dealing with a neck issue. **Reuters**

IDFC First Bank to Raise ₹3,200 cr Via Pref Issue

Mumbai: IDFC First Bank has proposed to raise ₹3,200 crore capital by issuing preferential shares to six insurance companies, including Life Insurance Corp, the private bank disclosed to the exchange.

The bank's board, which met today, approved a proposal to issue preferential shares at ₹80.63 per equity share, which is higher than Thursday's closing price of ₹77.55.

Among investors, LIC will invest ₹1,500 crore, HDFC Life Insurance is ₹650 crore, Aditya Birla Sun Life Insurance is ₹500 crore, Bajaj Allianz Life

Insurance and ICICI Lombard General Insurance are ₹250 crore each, while SBI General Insurance is ₹50 crore in the preference shares.

Post allotment, LIC will hold 2.6%, HDFC Life will hold 1.3% and Aditya Birla Sun Life will hold 1.06%. The remaining three insurance companies will hold less than 1%.

The capital adequacy ratio of the bank will increase to 17.49% from 16.11% now.

The net profit of the bank increased 21% to ₹2,957 crore in FY24 from ₹2,437 crore in FY23.

ROW OVER TRADEMARK IN HC

Asked Vendors to Remove 'Tesla' Mark: Indian Firm

New Delhi: Gurugram-based Tesla Power India on Thursday told the Delhi High Court that it has written to its vendors and partners for removal of the Tesla marks on electric scooters, after US electric vehicle maker Tesla Inc objected to it.

The court that it would fully abide by its undertaking that it had no plans to enter the electric vehicle market. "We don't wish to sell anything beyond the undertaking," the company said, adding that emails were sent to all its franchisees against selling anything under the company's brand.

The HC on Tuesday had asked Tesla Power to file an affidavit on the number of electric scooters sold and the current stocks available with it, after Tesla Inc accused the Gurugram firm of selling electric scooters through dealers under various sub-brands even after giving an undertaking to the court.

Justice Anish Dayal asked Tesla Power to take further steps to ensure that the undertaking given by it was complied with, and posted the matter for further hearing on July 4. On May 2, the court directed the Indian company not to is-

sue any promotional advertisements featuring electric vehicle products with the "Tesla" brand until the next date of hearing.

According to US-based Tesla Inc, an independent investigation had shown images of electric scooters with the brand name that were available for sale. Photographs and brochures of the electric vehicle have been put on record, it added.

India Ratings Upgrades Adani Green, Says Outlook is Stable

Mumbai: India Ratings and Research (Ind-Ra) on Thursday upgraded Adani Green Energy's (AGEL) long-term issuer rating to 'IND AA+' from 'IND A+', saying the company's outlook is stable.

Among the key rating drivers are AGEL being the largest renewable developer in India with sound operating parameters of operational assets and healthy free cash flow to equity, along with promoter infusion covering equity commitments, the rating agency said.

According to Ind-Ra, the upgrade also reflects AGEL's change in policy with respect

to the leveraging of the holding company, as the company has now earmarked funds towards the repayment of \$750 million hold-co bond.

"In addition, the upgrade factors in the creation of a platform within AGEL with Total Energies SE, which allows for part asset monetisation while retaining consolidation benefits..."

The upgrade factors in the continued strong operational asset performance include "strong execution scale-up", with annual capacity additions likely to be 4GW-5GW over the medium term from the earlier 2.5-3.5GW.

डॉक्टरांकडून एका व्यक्तीकडे सुपूर्द; पोलिसांकडून शोध

पुण्यातील अपघात प्रकरणात कार्यालयात अल्पवयीन मुलाच्या रक्ताचे नमुने ससून रुग्णालयात 'सीसीटीव्ही' नसलेल्या ठिकाणी घेण्यात आले होते. त्याची 'सीरिज' डॉ. श्रीहरी हाळनोर याने कचरापेटेटीत न टाकता एका व्यक्तीकडे दिली व त्याऐवजी एका महिलेच्या रक्ताचे नमुने घेण्यात आले. त्यामुळे अल्पवयीन मुलाच्या रक्ताचे नमुने ताब्यात असलेली संबंधित व्यक्ती आणि महिलेचा शोध घेण्यात येत आहे, असे तपास अधिकाऱ्यांनी गुरुवारी न्यायालयात सांगितले.

'पोश' कार भरधाव चालवून तरुण-तरुणीच्या अपघाती मृत्यूस कारणीभूत ठरलेल्या अल्पवयीन मुलाला वाचविण्यासाठी रक्ताचे नमुने बदलण्याचा प्रतप केल्याप्रकरणी ससून रुग्णालयातील न्यायवैद्यक शास्त्र विभागाचे (फॉरेंसिक डिपार्टमेंट) प्रमुख डॉ. अजय तावरे, आपकालीन विभागाचे मुख्य वैद्यकीय अधिकारी डॉ.

पुण्यातील अपघातांनंतर शहरातील पब, बार, रेस्टॉरंट रेडारवर आले आहेत. त्यामुळे त्यांच्याविरोधात कारवाईचा सपाटा सुरूच असून, आता आणखी ६६ पब, बार, रेस्टॉरंटला टाळे ठोकण्यासाठी जिल्हाधिकाऱ्यांकडे प्रस्ताव पाठविण्यात आले आहेत. आतापर्यंत ६६ पब, बारला टाळे ठोकले असून, त्यात आणखी भर पडणार असल्याने शहर परिसरातील १३२ पब, बार बंद पडणार आहेत.

आतापर्यंत पब, बारबाबत नरमाईची भूमिका घेणाऱ्या उत्पादन शुल्क अधिकाऱ्यांनी शहरातील पब, बारवर लक्ष केंद्रित केले आहे. पब, बारवर कारवाईसाठी उत्पादन शुल्क विभागाने १७ पथके तयार केली आहेत. पथकात पाच ते सहा अधिकारी, कर्मचारी यांचा समावेश आहे.
