New Delhi, July 23 (IANS) Union Finance Minister Nirmala Sitharaman on Tuesday provided an allocation of Rs 2.2 lakh crore for urban housing, along with a Rs 10 lakh crore interest subsidy scheme in the flagship Pradhan Mantri Awas

Yojana (PMAY) scheme. This will give further impetus to the government's programme to provide affordable housing. "Housing needs of one crore urban poor and middle-class families to be addressed with an investment of Rs 10 lakh crore, including the Central assistance of Rs 2.2 lakh crore over the next five years," FM Sitharaman

said in her Budget Speech in Parliament.

Business Brief III

Review of Income Tax Act announced in Union Budget

New Delhi, July 23 (IANS) Finance Minister Nirmala Sitharaman announced a review of the Income Tax Act 1961 in Budget proposals for 2024-25. "I am now announcing a comprehensive review of the Income-tax Act, 1961. The purpose is to make the Act concise, lucid and easy to read and understand. This will reduce disputes and litigation, thereby providing tax certainty to the taxpayers. It will also bring down the demand embroiled in litigation. It is proposed to be completed in six months," she said in her Budget speech. "A beginning is being made in the Finance Bill by simplifying the tax regime for charities, TDS rate structure, provisions for reassessment and search provisions and capital gains taxation," she said. As per the proposal, the two tax exemption regimes for charities are proposed to be merged into one. The 5 per cent TDS rate on many payments is being merged into the 2 per cent TDS rate and the 20 per cent TDS rate on repurchase of units by mutual funds or UTI is being withdrawn. The TDS rate on e-commerce operators is proposed to be reduced from one to 0.1 per cent. "Moreover, credit of TCS is proposed to be given in the TDS to be deducted from salary. Further, I propose to decriminalize delay for payment of TDS up to the due date of filing statement for the same. I also plan to provide a standard operating procedure for TDS defaults and simplify and rationalise the compounding guidelines for such defaults," the Finance Minister said.

Six Russians, three others detained by TN Police near Kudankulam nuclear power plant

Chennai, July 23 (IANS) Tamil Nadu Police have taken into custody six Russian citizens and three Indians from near the nuclear reactor plant at Kudankulam. A senior police officer told IANS that they were taken into custody on Monday evening after local people tipped off on the presence of foreigners around the premises of the nuclear reactor. Besides six Russians including a woman, two Tamil Nadu natives and a Keralaite from Thiruvananthapuram were also taken into custody by the police. Sources in Tamil Nadu Police told IANS that the Central agencies have commenced quizzing those in custody. The Thiruvananthapuram native, according to police, is the driver of the cab in which the Russians came.

Assessments to be reopened beyond 3 years only if escaped income is more than Rs 50 lakh

New Delhi, July 23 (IANS) The Union Budget for 2024-25 has proposed provisions to simplify the provisions for reopening and reassessment. Finance Minister Nirmala Sitharaman announced that an assessment hereinafter can be reopened beyond three years from the end of the assessment year only if the escaped income is Rs 50 lakh or more, up to a maximum period of five years from the end of the assessment year. Even in search cases, a time limit of six years before the year of search, as against the existing time limit of ten years, is proposed. This will reduce tax uncertainty and disputes, she said. "While our concerted efforts to reduce pendency of appeals at various appellate fora are beginning to show good results, it will continue to engage our highest attention," the Finance Minister said. She said that to dispose of the backlog of first appeals, I plan to deploy more officers to hear and decide such appeals, especially those with large tax effects.

Tax exemption only in new regime will encourage people to move from old one: Experts

Kolkata, July 23 (IANS) Union Finance Minister Nirmala Sitharaman's announcement of tax exemption only for those opting for the new tax regime will encourage more taxpayers to shift from the old to the new system in days to come, say economists and investment consultants.

Union Budget 2024: What becomes cheaper and what's costlier?

New Delhi, July 23 (IANS) With Finance Minister Nirmala Sitharaman announcing a major reduction in customs duty on cancer drugs and mobile phones, it is set to considerably bring down their prices in the market.

The Finance Minister also announced a reduction of customs duty on mobile phones and mobile chargers to 15 per cent.

"The government will exempt three cancer treatment drugs from customs duty. I will also reduce basic customs duty on mobile phones, chargers and other mobile parts," FM Sitharaman said presenting the Budget 2024.

Union Budget: Boost to youth empowerment, women in workforce

New Delhi, July 23 (IANS) As Union Finance Minister Nirmala Sitharaman presented her seventh Budget on Tuesday, among several things, she put forth the government's vision for the empowerment of youth.

One of the highlights of this budget is grant of one month's wage for first-time employees, which will be provided to them as a Provident Fund contribution.

There will also be provision for internships in 500 established companies, which will be encouraged among youth.

Additionally, an internship allowance of Rs 5000 and a one-time assistance of Rs 6,000 are to be provided under the internship scheme, the Finance Minister said.

Union Budget: Mudra loan limit enhanced to Rs 20 lakh from Rs 10 lakh

New Delhi, July 23 (IANS) The government on Tuesday announced several measures to boost the sentiments of the non-farming business community and MSMEs, along with enhancing Mudra loans to Rs 20 lakh from Rs 10 lakh.

While delivering the Union Budget 2024-2025 speech in the Lok Sabha, Finance Minister Nirmala Sitharaman said that this extension applies to those who have availed and paid previous Mudra loans.

Pradhan Mantri Mudra Yojana (PMMY) is a flagship scheme of the gov-

ernment which facilitates micro credit/loan up to Rs 10 lakh to income generating micro enterprises engaged in the non-farm sector in manufacturing, trading or service sectors including activities allied to agriculture such as poultry, dairy, beekeeping, etc.

The scheme provides financial assistance extended by member lending institutions to the non-corporate, non-farm sector income generating activities of micro and small entities. The budget also provides special attention to MSMEs and manufacturing.

GST reduced tax incidence on common man, to be expanded to remaining sectors

New Delhi, July 23 (IANS) The Centre on Tuesday said Goods and Services Tax (GST) has decreased tax incidence on the common man, reduced compliance burden and logistics cost for trade and industry, and enhanced revenues of the Central and state governments.

The Union Budget 2024-25 indicated that GST will be expanded to the remaining sectors.

"It is a success of vast proportions. To multiply the benefits of GST, we will strive to further simplify and rationalise the tax structure and endeavor

to expand it to the remaining sectors," said Finance Minister Nirmala Sitharaman.

All the major taxpayer services under GST and most services under Customs and Income Tax have been digitised.

India's gross GST collection rose to Rs 1.74 lakh crore in June this year representing a 7.7 per cent increase over the same month last year, according to sources.

This takes the total GST mop-up for the first three months of the current financial year to Rs 5.57 lakh crore. In April 2023, GST collection

had soared to a record high of Rs 1.87 lakh crore. According to experts, the GST reforms, which have eased compliance and reduced tax burdens, have been instrumental in driving economic growth.

"The proposed rationalization of the tax structure, coupled with the new tax regime changes, including the increased standard deduction, will further benefit the salaried class and boost disposable income, positively impacting housing demand," said Prashant Sharma, President, NAREDCO, Maharashtra.

Telangana Assembly condoles death of former BRS MLA Nandita

Hyderabad, July 23 (IANS) Telangana Assembly on Tuesday condoled the death of former MLA of Secunderabad Cantonment constituency Lasya Nandita.

As soon as the Budget session began, Chief Minister A. Revanth Reddy moved a condolence motion.

Members cutting across party lines paid tributes to Nandita, who died in a road accident on February 23.

The 37-year-old passed away within three

months after getting elected to the Assembly as the Bharat Rashtira Samithi (BRS) candidate.

She was the daughter of BRS leader and five-time MLA from Secunderabad Cantonment constituency, G. Sayanna, who had passed away on February 19 last year due to illness.

In the by-election held on May 13 to fill the vacancy caused by Nandita's death, the ruling Congress wrested the seat from BRS. Nandita's sister Nivedita, fielded by BRS,

had finished third.

Moving the condolence resolution, the Chief Minister recalled that he had a close association with Sayanna, who was born into a very ordinary family and reached the height of his political career. Sayanna was soft-spoken and maintained friendly relations with everyone irrespective of their political affiliation. He said Sayanna fought for the merger of Secunderabad Cantonment with Greater Hyderabad Municipal Corporation (GHMC).

FM Sitharaman gifts 2 Expressways to Bihar, allots Rs 15,000 cr for Andhra

New Delhi, July 23 (IANS) Presenting her seventh-consecutive Budget, Finance Minister Nirmala Sitharaman on Tuesday announced landmark projects and also fund allocations in Bihar and Andhra Pradesh, the states whose ruling parties are allies with the BJP at the Centre.

The announcement is crucial because of both states' demand for special category status and special packages, post their bifurcation.

Also, Bihar's JD(U) and Andhra's TDP-Janaseena are BJP's ally partners at the Centre.

FM Sitharaman announced two major Ex-

pressways for Bihar, namely Patna-Purnia Expressway and Buxar-Bhagalpur Expressway.

FM Sitharaman also announced that new airports, medical colleges and sports infrastructure will be constructed in Bihar.

"Request of Bihar government for external assistance from multilateral banks will also be expedited," she said.

Addressing the monetary concerns of Andhra Pradesh, she said that the government had made concerted efforts in recognising the state's need for capital, as per the Andhra Pradesh Re-organisation Act. A sum of Rs 15,000 crore will be arranged in the current fiscal, with additional outlays in future years," said the Finance Minister.

Moreover, two land bridges over Ganga River will come up in Buxar District.

These projects, with a total cost of Rs 26,000 crore will give Bihar's road infrastructure a major facelift and open new avenues for growth.

K'taka Cabinet gives consent for resolutions against NEET, 'One Nation, One Election' & delimitation

Bengaluru, July 23 (IANS) The Karnataka Cabinet has decided to pass three resolutions, including the one against the National Eligibility-cum-Entrance Test (NEET), late Monday night, sources said.

The Cabinet meeting, chaired by Chief Minister Siddaramaiah, also approved the passing of the other two resolutions against 'One Nation, One Election' and the delimitation of Assembly and Lok Sabha constituencies as

they are under consideration by the Union government.

The Cabinet will table all three resolutions in the State Legislature on Tuesday, according to sources. The move is likely to trigger controversy and debate.

The Cabinet also approved the Greater Bengaluru Governance Bill, 2024, which proposes decentralising power at various levels under the Greater Bengaluru Authority and will also include city

corporations.

Chief Minister Siddaramaiah will be the President of the Greater Bengaluru Authority.

Sources also said that the Cabinet discussed the controversial private sector quota for local Kannadigas at length under the proposed Karnataka State Employment of Local Candidates in the Industries, Factories and Other Establishments Bill, 2024. The bill has been kept in abeyance following backlash.

FM Sitharaman lays out roadmap to pursue 9 priorities for shining India opportunity

New Delhi, July 23 (IANS) Union Finance Minister Nirmala Sitharaman on Tuesday laid out nine priorities of Prime Minister Narendra Modi's government, with a focus on employment, skilling, agriculture and manufacturing.

These are -- agriculture, employment, inclusive development, manufacturing and services, urban development, energy, infrastructure, innovation R&D and next-gen reforms. The Budget provides Rs 2.66 lakh crore for rural development.

"In this budget, we focus on employment, skilling, MSMEs and the middle class. Agriculture research will be transformed to focus on raising productivity and climate resilient varieties," said FM Sitharaman while presenting her seventh Budget.

Centre took revenge for losing 11 seats in Raj via budget: Dotasra

Jaipur, July 23 (IANS) The Rajasthan Congress on Tuesday launched a scathing attack on the Narendra Modi government, saying the Centre has taken revenge for losing 11 Lok Sabha seats in the desert state via the Union Budget 2024-25. State Congress chief Govind Singh Dotasra said the Centre has been kind to two states which are Nitish Kumar's Bihar and Chandrababu Naidu's Andhra Pradesh.
