The Scheme has been approved vide order dated 05th August 2024.

As consideration for the demerger all the shareholders of SGR Infratech Private Limited ("Demerged Company"/ "Promoter Group" of the Company) have been allotted shares of Vibrant Infotech (Nagpur) Private Limited ("Resulting Company"). 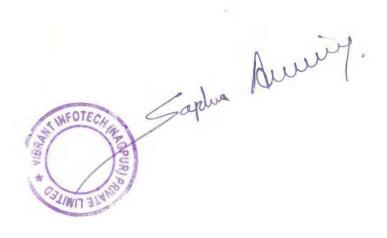
