## Item No. 2 Re-appointment of the Statutory Auditor

M/s. Bipin & Co., Chartered Accountants, Vadodara (Firm registration number 101509W), were appointed as Statutory Auditors of the Company at the 35<sup>th</sup> Annual General Meeting held on 19<sup>th</sup> September 2020 for a term of first 3 years upto the conclusion of this 38<sup>th</sup> Annual General Meeting. M/s. Bipin & Co. are eligible for re-appointment as statutory auditors of the company. M/s. Bipin & Co. have given their consent for their re-appointment as Statutory Auditors of the Company and has issued certificate confirming that their re-appointment, if made, will be within the limits prescribed under the provisions of Section 139 of the Companies Act, 2013 ('the Act') and the rules made thereunder. M/s. Bipin & Co. have confirmed that they are eligible for the proposed appointment under the Act.

The remuneration proposed to be paid to the Statutory Auditors would be in line with the existing remuneration and shall be commensurate with the services to be rendered by them during the said tenure. The Board of Directors in consultation with the Audit Committee may alter and vary the terms and conditions of appointment, including remuneration, in such manner and to such extent as may be mutually agreed with the Statutory Auditors.

## Item No. 4. Re-appointment of Ms. Manisha Patel as an Independent Director
