## PUBLIC NOTICE

It is brought to the attention of the general public that Indraprastha Apollo Hospitals, New Delhi ("Indraprastha Apollo") owned and run by Indraprastha Medical Corporation Limited ('IMCL'), operates an organ transplant program within the strict confines of the law and rules governing it. The hospital neither encourages not provides approval for any act/s by our staff, doctors, partners, patients or the general public that contravenes the law and rules governing organ transplantation. The hospital voluntarily and otherwise undergoes periodic evaluation of its program, through external competent statutory authorities and internal bodies of IMCL, to ensure compliance with the law.

IMCL has an Authorization Committee - an independent body, comprising of members from the hospital, independent members, and government appointees, approved by the Government of Delhi NCT, which scrupulously scrutinizes all documents including documents of relevant government authorities and the embassy of the donor and recipient's country of origin and grants approval only after a thorough and independent satisfaction of altruistic nature of organ transplant.

For organ transplants in foreign nationals, relevant approvals, undertakings and verifications must be obtained from the embassy concerned in New Delhi, including compliance with the requirements of Form 21 of the Transplantation of Human Organs Act 1994 ("THOA").

IMCL does not solicit organ donations for monetary considerations, and the public is advised to report any such information being falsely circulated to the hospital (infodelhi@apollohospitals.com) and/or law enforcement agencies.

It may be noted that IMCL does not create any WhatsApp Groups and/or does not disseminate any information on WhatsApp and the public is advised not to be misled by any unauthentic information.

It may be noted that as India's leading multi-specialty tertiary care facility, the hospital is cognizant of, and committed to follow, the law of the land including, but not limited to, the provisions contained in the Transplantation of Human Organs and Tissues Act, 1994 and the Transplantation of Human Organs and Tissues Rules, 2014, both in letter and in spirit, and has a robust system of comprehensive checks, safeguards, and compliances in place to ensure that all medical treatment, including but not limited to organ transplant procedures, is conducted in a legal and ethical manner.
