On 29th October 2002, troops of 48 Bn CRPF visited SMHS Hospital for a routine medical check-up. Taking advantage of the crowd, three militants approached HC/Armourer Virender Singh and Constable Ashok Kumar Patel and opened fire. Due to the presence of civilians, the troops could not retaliate. A search was launched, but the militants escaped. Both HC/Armourer Virender Singh and Constable Ashok Kumar Patel sustained critical injuries and later succumbed during treatment, attaining martyrdom.

On 4th October 1991, a patrol from 74 Battalion of CRPF, deployed in Anantnag, Jammu & Kashmir, was tasked with searching suspected militant hideouts. As they returned through a narrow lane, they were ambushed by 15-20 militants. The patrol swiftly retaliated, neutralising one and forcing the rest to flee. During the exchange, Constable Girdhar Choubey was critically injured but continued to fight before collapsing. He was evacuated to the hospital, where he succumbed to his injuries on 29th October 1991, attaining martyrdom.

Shaheed Nk/Dvr R. D. Chaudhary

02-11-1952 To 29-10-1990

On 29th October 1990, 53 Battalion of CRPF was deployed in Anantnag, Jammu & Kashmir, for counter-insurgency operations. Nk/Dvr R. D. Chaudhary was driving a vehicle with Constable Dharnidhar Nath as part of the escort. As the vehicle turned a corner in Nai Basti, militants opened fire. The escort party and a second vehicle responded, but the attackers fled. Both Nk/Dvr R. D. Chaudhary and Constable Dharnidhar Nath sustained bullet injuries. Nk/Dvr R. D. Chaudhary was martyred instantly, while Ct Dharnidhar Nath succumbed to his injuries on 30th October, both making the ultimate sacrifice in the line of duty.

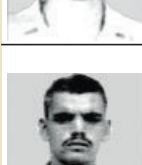
