Subject: Resignation from the Position of Auditor

Dear Board of Directors,

I am writing to formally tender my resignation as the Auditor of Brightcom Group Ltd, effective 6th August, 2024.

My resignation is prompted by several significant issues:

- 1. Lack of Required Information: We were not provided with the necessary information and documentation to complete our client evaluation and review under the client acceptance section of the Standards on Quality Control (SQC) issued by the Institute of Chartered Accountants of India (ICAI). The management has not supplied adequate information and records, and we were not given sufficient time to address these issues. This has significantly impeded our ability to assess the client's acceptance and carry out our audit responsibilities effectively.
- **2. Inadequate Cooperation**: The lack of cooperation from the Company in providing essential documentation and information has impeded our ability to carry out our audit responsibilities effectively. This situation has compromised our ability to meet both professional and statutory obligations.
- **3.** Approval of Appointment: It has come to our attention that the appointment of the auditor needs to be approved by the shareholders at a general meeting within three months. As this approval has not been obtained, it places our position as auditors in a state of uncertainty. We are concerned about whether we have properly assumed the office of the auditor and whether our appointment complies with the legal requirements. The company has not even filed ADT-1, with MCA for which the time is already over.
- **4. Responsibility for Quarterly Reviews**: Given that the quarterly reviews were delayed significantly beyond the 45-day period required, we assume that we are not responsible for any further quarterly

reviews. The delays have impacted our ability to complete the reviews within the prescribed timeframe.

Please acknowledge receipt of this resignation letter and confirm the acceptance of our resignation at your earliest convenience. We would appreciate any guidance on the next steps and the necessary procedures to ensure compliance with all relevant regulations.
