Dear Sir/Ma'am,

We are in receipt of your e-mail bearing ref. no. L/SURV/ONL/RV/CM/(2024-2025)/ 82 dated November 8, 2024, seeking a clarification on news item appearing on "<https://economictimes.indiatimes.com>" captioned "**CCI probe finds Zomato, Swiggy breached antitrust laws**".

In this regard, we would like you to note that the Hon'ble Competition Commission of India ("**Commission**") had issued a prima facie order on April 4, 2022, which directed the Office of the Director General of the Commission ("**DG**") to investigate potential violations under the Competition Act, 2002 (*as amended*) ("**Competition Act**") ("**Prima Facie Order**").

The Prima Facie Order was disclosed to the stock exchanges on April 5, 2022, pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**LODR Regulations**"). A copy of the said disclosure is attached as **Annexure A**.

Since the intimation of April 5, 2022, the Commission, on merits, has not passed any order. Hence, there have been no further reportable events under the LODR Regulations that obligates the Company to make any disclosures under Regulation 30.

Accordingly, the aforementioned news article is misleading. We will continue to work closely with the Commission to explain why all our practices are in compliance with the Competition Act and that they do not have any adverse effect on competition in India.

**Sub: Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')**

The Hon'ble Competition Commission of India ('Hon'ble Commission') has passed an order dated April 4, 2022 under Section 26(1) of Competition Act, 2002 initiating investigation on certain aspects of our business along with those of Bundl Technologies Private Limited ('Swiggy'). This order has been passed subsequent to information first considered by the Hon'ble Commission in August 2021.

In their order, the Hon'ble Commission has mentioned that it has prima facie not found concerns with respect to our independence on levy of commissions or alleged bundling of services, while it would want to investigate aspects such as preferential listing of restaurant partners and pricing parity across platforms, etc.

We will continue to work closely with the Hon'ble Commission to assist them with their investigation and explain to the regulator why all of our practices are in compliance with competition laws and do not have any adverse effect on competition in India. We intend to promptly comply with any recommendations given to us by the Hon'ble Commission.

The details required in the Listing Regulations are attached as Annexure-A. Please note that the above information is disclosed to the exchange pursuant to Regulation 30 of the Listing Regulations.
