चण्डीगढ़, 14 अगस्त, सत्यजय टाइम्स। हरियाणा के मुख्यमंत्री नायब सिंह सैनी ने कहा कि राष्ट्र ध्वज तिरंगा हमारी स्वतंत्रता और सार्वभौमिकता का प्रतीक है। यह देश की शान, गौरव और अभिमान है। यह हमें हर क्षण देशभक्ति की प्रेरणा देता है। प्रधानमंत्री नरेंद्र मोदी ने वर्ष 2022 में आजादी के अमृत महोत्सव के दौरान स्वतंत्रता दिवस से कुछ दिन पहले हर घर तिरंगा अभियान शुरू किया था। उन्होंने देशवासियों से अपील करते हुए कहा कि हर वर्ष स्वतंत्रता दिवस पर देश के हर घर पर तिरंगा फहराया जाए।
