This is in reference to your email dated June 28, 2024.

Dear Sir/Madam,

This is with reference to your communication regarding the non-compliance/late compliance with Regulation 23 (9) pertaining to the disclosure of related party transactions on a consolidated basis, and the imposition of a fine amounting to Rs. 5,900/-(Inclusive of GST).

With reference to above, we wish to clarify that, as per the proviso to sub-regulation 9 of Regulation 23, a listed entity is mandated to make related party disclosures every six months on the date of publication of its standalone and consolidated financial results, effective from April 1, 2023. We interpreted the amendment to mean that the disclosure under Regulation 23(9) should be submitted on the date on which the Company publishes its financial results in the newspaper. Accordingly, the disclosure of related party transactions was submitted on 30th May 2024, the same date on which the Company published its financial results in the newspaper.

In light of the above, we understand that this delay was a result of an inadvertent interpretation. We kindly request a waiver of the fine imposed, as the omission to file the document in a timely manner was unintentional and due to a misinterpretation.

Please be assured that we have taken immediate corrective measures to prevent such occurrences in the future. The issue will be presented before the Board of Directors at the next meeting, and the comments made by the Board will be duly communicated to the Exchange for dissemination.

We seek your understanding and cooperation in this matter.
