हिटलर की तरह मुसलमानों को टारगेट कर रहा है आरएसएस



भोपाल,(निप्र)। पूर्व मुख्यमंत्री दिग्विजय सिंह ने शनिवार को सीपीआईएम के दफ्तर प्रेस वार्ता कर आरएसएस और वीडी शर्मा पर जमकर हमला बोला। दिग्विजय ने कहा मसलमानों को हिटलर की तरह आरएसएस टारगेट कर रहा है। उन्होंने वीडी शर्मा को नपुंसक तक कह दिया।

बता दें पूर्व सीएम दिग्विजय सिंह ने शनिवार को भोपाल के पद्मनाभ नगर में मीडिया से चर्चा की। इस दौरान इंडिया गठबंधन के सदस्यों ने छतरपुर में मुसलमान परिवारों के साथ हुई ज्यादती की घटनाओं की रिपोर्ट बताई। वहीं दिग्विजय ने बीजेपी के प्रदेश अध्यक्ष वीडी शर्मा को नपुंसक बताते हुए कहा है कि वीडी शर्मा उन्हें आतंकियों का हिमायती मानते हैं, तो उनकी नपुंसकता पर मुझे निराशा होती है। टिपल इंजन सरकार में होकर भी कार्रवाई नहीं करते। उन्होंने कहा कि देश में जो गवर्नेंस आफ नरेंद्र मोदी चल रहा है, उसमें तुम भी खाओ, हमको भी खिलाओ वाली नीति लागू है। दिग्विजय सिंह ने छतरपुर में पुलिस पर फायरिंग करने वाले की हवेली गिराने पर कहा कि प्रशासन ने एकतरफा कार्रवाई की है। देश में सुनियोजित ढंग से भाजपा और उनके संगठनों ने कार्रवाई की है। जैसे, हिटलर ने यहदियों को टारगेट बनाया। उसी तर्ज पर आरएसएस ने मुसलमानों को टारगेट किया है। उन्हें एंटी नेशनल बताने का काम किया जा रहा है। सिंह ने कहा कि अंग्रेजों ने जैसे हिन्दू मुस्लिम को अलग किया उसी से सीख लेकर आरएसएस-भाजपा काम कर रही है।

Will bring law restricting land dealings: Sarma

GUWAHATI

Chief Minister Assam Himanta Biswa Sarma on Sunday said that his government is working on a law to allow land dealings in select revenue circles only between people who have been residents of the state since at least 1951.

He said new laws are being enacted and amendments being made to existing Acts to ensure and protect land rights of the indigenous people, while also giving settlement rights to the landless, eligible dwellers, Sarma was speaking at the launch of e-Chitha Land Valuation Certification portal.

He said similar laws, like one allowing land dealings

only within the same category in the case of Scheduled Castes, Schedules Tribes and Other Backward Classes in undivided Goalpara district, will be brought by his government. Through an amendment to another existing law, the sale of tea land for non-tea growing purposes without government consent has been made a punishable offence, Sarma said. It was in line with the Justice Biplab Sarma committee report on the implementation of Clause 6 of the Assam Accord. On other land-related reforms being pursued by his government, the CM said Mission Basundhara will be launched on Oct 2, incorporating the success and experiences of the first two editions.

U'khand orders probe into gangster-mahant case

DEHRADUN

The Uttarakhand government on Sunday ordered an inquiry into the matter of underworld don Prakash Pandey alias PP being given the title of Mahant in Almora jail.

Special Secretary (Home) Riddhim Agarwal has nominated Additional Inspector General, Prison Administration, Yashwant Chauhan as the investigating officer in the case and asked him to report

within a week.

Pandey, involved in several cases of murder, robbery and ransom, was given 'diksha' by two sadhus inside the jail on September 5. As part of the ritual, the gangster was made to wear a 'rudraksha' rosary and 'kanthi' amid mantra chanting. The sadhus, who claimed to be from the Panch Dashnam Juna Akhara, also gave Pandey a new name, Prakashanand Giri after the ceremony. The sadhus were joined by mediators.

Algerians vote to elect president



Algerians headed to polls on Saturday to elect their next president, with more than 23 million citizens in the country eligible to cast their ballots. Voting began early in the day, with polling stations nationwide opening at 8:00 a.m. local time. Mobile polling stations have been in operation since Wednesday to access remote areas, while overseas voting commenced on Monday, catering to over 800,000 Algerians living abroad, Xinhua news agency reported.

Mural hung in Pfizer's NYC lobby for 60 years is now up for grabs

NEW YORK

A mural honouring ancient and modern figures in medicine that has hung in the lobby of Pfizer's original New York City headquarters for more than 60 years could soon end up in pieces if conservationists can't find a new home for it in the next few weeks.

"Medical Research Through the Ages," a massive metal and tile mosaic depicting scientists and lab equipment, has been visible through the high glass-windowed lobby of the pharmaceutical giant's midtown Manhattan office since the 1960s.

But the building is being gutted and converted into residential apartments, and the new owners have given the mural a move-out date of as soon as September 10.

Art conservationists and the late artist's daughters are now scrambling to find a patron who is able to cover the tens of thousands of dollars they estimate it will take to move and remount it, as well as an institution that can display it. "I would ideally like to see it as part of an educational future, whether it's on a hospital campus as part of a school or a college. Or part of a larger public art program for the citizens of New York City," said art historian and urban planner Andrew Cronson, one of the people trying to find a new home for the piece.

The 40-foot-wide and 18foot-high (12 metres by 5.5 metres) mural by Greek American artist Nikos Bel-Jon was the main showpiece of Pfizer's world headquarters when the building opened a few blocks from Grand Central Terminal in 1961, at a time when flashy buildings and grand corporate art projects were a symbol of business success.

Ukraine shoots down scores of Russian drones

The Joint Chiefs of Staff (JCS) said the balloons could travel to Gyeonggi Province that surrounds Seoul, warning the public of falling objects and asking people to report balloons to the military or police, Yonhap news agency reported. The latest launches came after the North floated

some 190 balloons from Friday night to early Saturday morning, with around 100 trash bundles landing in the capital and Gyeonggi Province, according to the JCS.

No hazardous materials have been found in the balloons, which largely contained scrap paper, pieces of plastic and plastic bottles.

Since late May, the North has launched thousands of balloons carrying trash in retaliation against anti-Pyongvang leaflets sent across the border by North Korean defectors and activists in South
