Pursuant to Regulation 30(4) read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation of our earlier intimation dated 05th February, 2024, we inform that on further investigation and findings during our audit for March 2024 by statutory auditor we found out that earlier mentioned employee (Mr. Manoj Sarvaiya) has committed an additional fraud by transferring securities from certain DP accounts to his personal DP account, as on 31st March, 2024 the market value of such securities is Rs. 146 Lakhs.

The brief particulars of fraud committed by the employee given below as per SEBI Circular dated July 13, 2023:

a. Nature of fraud: Fraudulently transferring securities from certain DP accounts to his personal DP account as on 31-03-2024, the market value of such securities is Rs 146 lacs.

- b. Estimated impact: One-time impact on the profitability to the extent of the amount misappropriated.
- **c. Time of occurrence:** Committed over a period of time and first detected during the quarter ended December 2023 and then in March 2024.
- d. Persons involved: Mr. Manoj V. Sarvaiya.

e. Estimated amount involved (Rs.): Rs. 117.50 Lacs, the market value of shares as on 31-12-2023 Rs. 86 Lacs and additional amount as discovered during the audit of March 2024, the market value of shares as on 31st March, 2024 is Rs. 146 lakhs.

f. Whether such fraud has been reported to appropriate authorities: An initial police complaint was filled and no new action is taken till now for the additional findings.
