Notice is hereby given that the **56th Annual General Meeting** of M/s. Alkali Metals Limited will be held on **Wednesday the 21st August, 2024 at 11:00 A.M. ORDINARY BUSINESS

- 1) To receive, consider and adopt the Audited Financial Statements as on 31st March, 2024 together with the reports of the Directors and Auditors thereon.
- 2) To declare dividend for the financial year 2023-24.
- 3) To elect a Director in place of Ms. Y. Lalithya Poorna (DIN:00345471) who retires by rotation and is eligible for re-appointment.
- 4) To appoint M/s. C K S Associates, Chartered Accountants, Hyderabad (ICAI Firm Registration Number 007390S) as the statutory auditors of the company and if thought fit, to pass with or without modification the following resolution as an Ordinary resolution:

“RESOLVED THAT pursuant to provisions of Section 139(1) of the Companies Act, 2013 and the rules made there under, M/s. C K S Associates, Chartered Accountants, Hyderabad (ICAI Firm Registration Number 007390S) be and are hereby appointed as Statutory Auditors from the conclusion of this Annual General Meeting until the conclusion of the 6th consecutive Annual General Meeting (i.e till the AGM to be held in the year 2029), at a remuneration as may be fixed by the Board, in place of M/s. G. Nagendrasundaram & Co., Chartered Accountants, Hyderabad whose period of office is completed in terms of section 139(2).”

“RESOLVED THAT pursuant to the provisions of Sections 149, 150, 152 and any other applicable provisions of the Companies Act, 2013 and the Companies (Appointment and Qualification of Directors) Rules, 2014 (including any statutory modification(s) or re-enactment thereof for the time being in force) read with Schedule IV to the Companies Act and applicable regulations of the SEBI (LODR) Regulations, 2015 (as amended from time to time), Sri Murali Krishna Chevuturi (DIN: 01770851), who has submitted a declaration that he meets the criteria for independence as provided in the Companies Act and Listing Regulations, be and is hereby appointed as an Independent Non-Executive Director of the Company to hold office for a term of five consecutive years with effect from this 21st August, 2024 to 20th August, 2029.”



- 6) To consider and if thought fit, to pass with or without modification(s), the following resolution as a Special Resolution:

**NOTES**

1. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 in respect of Special Business set out above is annexed hereto and forms part of the Notice.
2. Brief resume of Directors proposed to be appointed/reappointed, (in item nos. 5, 6, 7 & 8) nature of their expertise in specific functional areas, name of companies in which they hold directorships as stipulated under Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 are provided as an Annexure to this notice
3. In compliance with the Ministry of Corporate Affairs (MCA) and Securities and Exchange Board of India (SEBI) Circulars to conduct their Annual General Meetings on or before 30th September, 2024 through video conferencing (VC) or other Audio Visual Means (OAVMs), the 56th Annual General Meeting (AGM) of the Company shall be conducted through Video Conferencing (VC).
4. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated 8th April, 2020, 13th April, 2020 and 5th May, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM/EGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the 56th AGM will be provided by CDSL. The Company has also appointed CDSL to provide Video Conferencing facility for 56th AGM.
5. At the 56th AGM through VC the members can attend the meeting through log in credentials provided to them to connect to Video Conference. Physical attendance of the Members at the Meeting venue is not required. While Body Corporates are entitled to appoint authorized representatives to attend the 56th AGM through VC and participate thereat and cast their votes through e-voting.
6. The Members can join the 56th AGM in the VC/OAVM mode 30 minutes before the Meeting and also after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice.
7. Up to 1000 members will be able to join on a First Come First Serve basis to the 56th AGM. Please note that there will be no restrictions on account of First Come First Serve basis entry into e-AGM in respect of large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc.. who are allowed to attend the AGM without restriction on account of first come first served basis.
8. The attendance of the Members (members' logins) attending the 56th AGM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
9. Pursuant to MCA Circular No. 14/2020 dated 8th April, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the 56th AGM through VC/OAVM and cast their votes through e-voting.



10. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated 13th April, 2020, the Notice calling the AGM has been uploaded on the website of the Company at **<https://www.alkalimetals.com/notice-of-the-meetings>**. The Notice can also be accessed from the websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively. The AGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM) i.e. **www.evotingindia.com**.
11. The Register of members and transfer books of the company will remain closed from **Saturday the 17th August, 2024 to Wednesday the 21st August, 2024 both days inclusive**.
12. The Securities and Exchange Board of India (SEBI) has mandated the submission of Permanent Account Number (PAN) by every participant in securities market. Members holding shares in electronic form are, therefore, requested to submit their PAN to their depository participants with whom they are maintaining their demat accounts.
13. Members, who hold shares in electronic/Demat form are requested to furnish the update/change of address, details of their bank accounts, viz, name of the bank, full address of the branch, account no. etc., to their respective Depository Participants and who hold shares in physical form to the Company's Registrars and Transfer Agents **M/s. Cameo Corporate Services Ltd., Subramanian Building, No.1, Club House Road, Chennai - 600002** so as to enable the Company to incorporate the bank details on the dividend warrants.
14. Pursuant to Section 72 of the Companies Act, 2013 and the Rules made there under the Members holding shares in single name may, at any time, nominate in form SH-13, any person as his/her nominee to whom the securities shall vest in the event of his/ her death. Nomination would help the nominees to get the shares transmitted in their favor without hassles. Members desirous of making any cancellation/variation in the said nomination can do so in SH-14.
15. Members holding shares in identical order of names in more than one folio are requested to write to the company's Registrars & Transfer Agents enclosing their share certificates to enable consolidation of their shareholdings in one folio. As per the amended Provisions based on the PAN, all different folios of the same PAN will be treated as one folio.
16. Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 9th December, 2020, under Regulation 44 of SEBI (LODR) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.



In compliance with provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time, Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations 2015 and Secretarial Standard on General Meetings (SS2) issued by the Institute of Company Secretaries of India, the Company is pleased to provide the members with facility to exercise their right to vote at the AGM by electronic means and the business may be transacted through remote e-voting Services provided by Central Depository Services (India) Limited (CDSL).

The **e-voting period commences on Sunday the 18th August, 2024 (9:00 A.M. IST) and ends on Tuesday 20th August, 2024 (05:00 P.M. IST)**. During this period shareholders of the Company, holding shares as on **cut-off date of Friday the 16th August, 2024** either in physical form or in Dematerialized form, may cast their vote electronically. The e-voting portal shall be disabled by CDSL for voting thereafter. Once the vote on a resolution is cast by the shareholder, the shareholder shall not be allowed to change it subsequently. The voting rights of shareholders shall be in proportion to their shares of the paid-up equity share capital of the Company. A member who has cast his/ her vote by electronic means are entitle to attend the AGM but not entitled to vote again at the AGM.

17. CS B. Venkatesh Babu, Company Secretary in Practice (F6708) has been appointed as the scrutinizer to scrutinize the remote e-voting process. The Scrutinizer shall, immediately after the conclusion of voting at the general meeting, will first count the votes cast at the meeting and thereafter unblock the votes cast through remote e-voting in the presence of at least two witnesses not in the employment of the Company and he will submit his report within the period not exceeding three working days from the conclusion of e-voting. The Chairman will declare the results on or after the AGM of the Company accordingly and will also be placed at the company website and also forward the same to the stock exchanges where the shares has been listed.

During the year 2023-24, the Company recorded a turnover of ₹ 8,285.59 Lakhs and Net Profit of ₹ 50.70 Lakhs compared to the turnover of ₹ 8,823.27 Lakhs and Net Profit of ₹ 282.09 Lakhs (after comprehensive items) of previous year 2022-23.

The global Industry slowdown and competition in the domestic market has contributed to a reduction in turnover by 6% as compared to the previous year. The overall Profit Before Tax was lesser by 59% as compared to the previous year which was mainly due to the lesser exports and the product composition.

2. Dividend

The Board of Directors recommend dividend of 10% amounting ₹ 1 per equity share of ₹10 each paid-up for the approval of the shareholders at the ensuing Annual General Meeting for the Financial Year 2023-24 and the said dividend will be paid to eligible shareholders as on the record date within 30 days of declaration by the shareholders.

3. Reserves

During the year under review, Company had not transferred any amount to General Reserves.

**4. Future outlook**

As per market forecast the Chemical Industry is expected to grow at a CAGR 12% p.a. However, the market scenario has changed post the global economic slowdown and the geo political environment has contributed to fall in demand in the Eurozone. Thereby the exports have come down leading to a fall in turnover.

The Company is continuously working to improve the performance. There have been efforts to identify new products and devise a better product mix. With the gradual improvement in the US and Europe Markets, the Company anticipates a better performance in the Financial Year 2024-25.

5. Research & Development

The Company has spent ₹ 133.63 Lakhs towards Research and Development during the Financial Year under review. The R&D team is putting its efforts to develop the new products and processes to ensure optimum material consumptions and effective yield.

6. Change in the nature of business, if any

The Company had not changed its nature of business during the year under review.

4. During the year, the Company had entered into related party transactions at arm's length price with the approval of the audit committee and Board.
5. The Company has transferred un claimed interim dividend and final dividend for the financial year 2015-16 to Investor Education and Protection Fund (IEPF) during the February 2023 and September 2023 respectively, but due to technical issues in the MCA website, the relevant excel file could not be filed. A ticket had been raised in this regard and the Company Officials are following up with the MCA Authorities and the Bank. During the month of February 2024, the Bank had confirmed that the amount which was transferred in February 2023 was reversed and it was parked in the Suspense Account of the Bank. The Company immediately requested the Bankers to transfer the funds from Suspense Account to IEPF Authorities Account. However, due to technical issue in the MCA portal, the challan is not getting linked due to which the Company is not able to file the relevant excel files.
6. The Company also transferred the shares who had not claimed the dividend for the last 7 years to IEPF on both February and September 2023. However, due to technical issues in the MCA website, the relevant form and excel file could not be filed. A ticket had been raised in this regard and the Company Officials are following up with the MCA Authorities.

MANAGEMENT DISCUSSION AND ANALYSIS

The Management Discussion and Analysis Report sets out developments in the business, environment and company's performance since our last report. The analysis supplements the Directors' Report and Audited Financial Statements which together form part of this Annual Report.

ECONOMY REVIEW

As per studies, Indian Chemical Industry was anticipating a big leap by estimating a reach of \$300 billions by 2024-25. However, for the past year it has been struggling with several headwinds, including uncertain demand, weak exports and intense competition. During the lockdown the world was looking towards India as an alternate supplier and this prompted many Indian Companies to stock up inventories to meet the opportunistic demand and also the fear of supply chain disruption was a contributor to this decision of over stocking. The result was a temporary boost in sales. However, once markets opened post pandemic, the global supply chain was restored and this led to intense competition in the global markets. Thereafter, the Eurozone and other markets had been under geopolitical stress contribution more problems and reduction in demand. The Indian Companies were facing an Over-Capacity scenario on the operational front due to the build-up in the inventory and sluggish demand. The Companies were also banking on shift from China and were also expecting an increased capex but due to the slowdown the capex plans have been put on hold or pushed to later years.

OUTLOOK

Despite the challenges, there is a sense of anticipated improvement in the global markets and Indian Chemical Industry holds promise and it is expected to be key contributor for the coming years. With the continuous R&D the product profile of the Indian Market is expected to improve and with-stand the global market demand. With the proposed infrastructure improvements, the Government's efforts to improve current FTA with ASEAN countries and introduction of PLI schemes it is an indication that the Indian Chemical Industry is on the way of improvement and the measure are being deployed to fine-tune it in the coming years in the global race.

- Lack of strategic initiatives to cover the Infrastructural deficit
- Lack of initiatives for diversification
- Regulatory complexities
- Higher tariffs compared to other countries in the same region
- Unfavourable Policy Support
- Sluggish demand due to Geo political situation across the European and other Countries

- Difficulty in maintaining margin

**PRODUCT PERFORMANCE**

All the products have performed in similar manner as compared to the previous year. The Company has sold 982 MT of finished products during 2023-24 and realized a turnover ₹ 82.85 crores. The Company sold sodium derivatives, pyridine derivatives and fine chemicals. The Company plans to continue its effort in developing new products.

INTERNAL CONTROL SYSTEM AND THEIR ADEQUACY

The Company has in place effective systems of internal control commensurate to its size and nature of business which provides for:

- Efficient use and safeguarding resources
- Accurate recording and custody of assets
- Compliance with prevalent statutes, policies, procedures, listing requirements, management guidelines and circulars.
- Transactions being accurately recorded, cross verified and promptly reported
- Adherence to applicable accounting standards and policies.
- IT systems which include controls for facilitating the above.

The internal control system provides for well documented policies, guidelines, authorizations and approval procedures. Also, the internal audit reports are laid before Audit Committee and discussions were held periodically by the Audit Committee at its meetings. The observations / findings made in internal audit reports, along with the status of action thereon are reviewed by the Audit committee of the Board of directors on a regular basis. The company has an exhaustive budgetary control system and the management regularly reviews actual performance

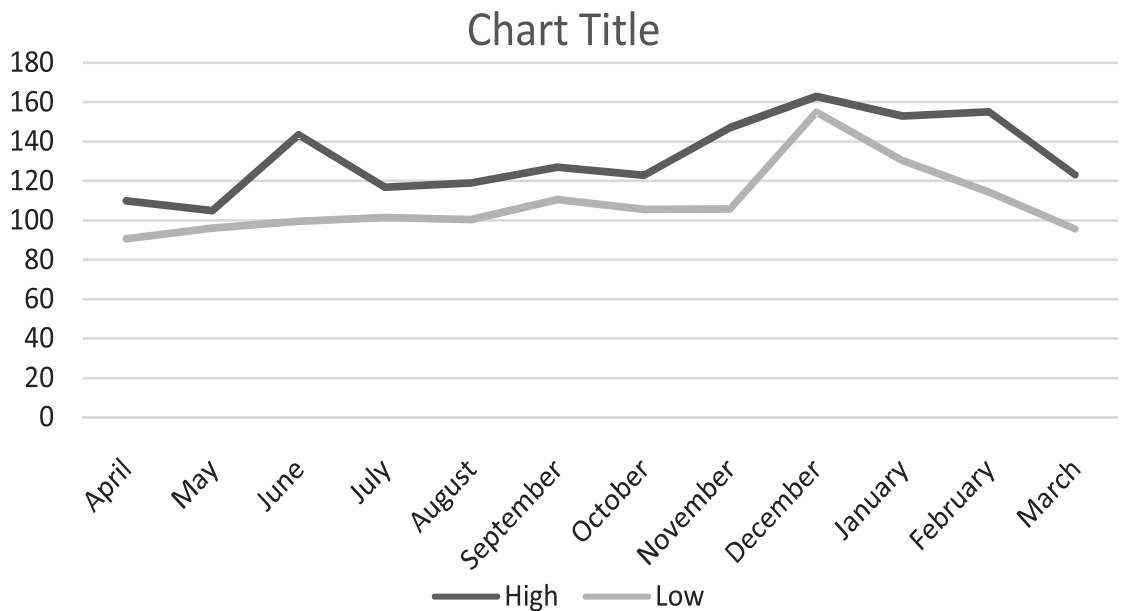

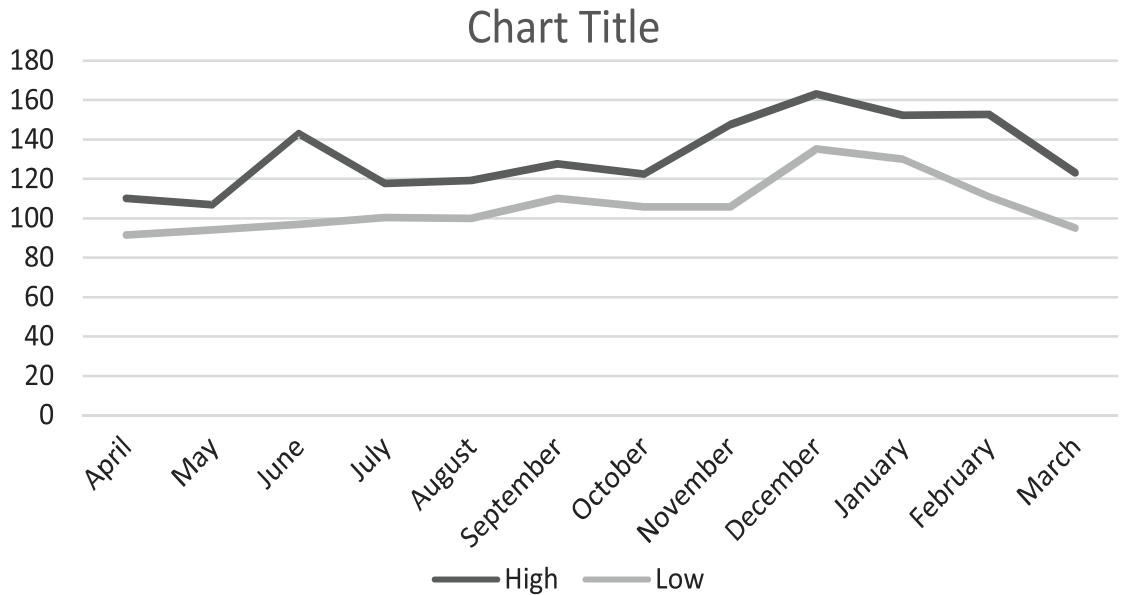

- v. The dividend declared and paid during the year by the Company is in compliance of Section 123 of the Companies Act, 2013.
- vi. Based on our examination, which included test checks, the Company has used accounting software for maintaining its books of account for the financial year ended March 31, 2024 which has a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the software. Further, during the course of our audit we did not come across any instance of the audit trail feature being tampered with.

1. COMPANY OVERVIEW

Alkali Metals Limited, which was established in 1968, at Hyderabad, Telangana, India, as a closely held Company. It became a Public Listed Company on 6th November 2008 being listed on BSE & NSE. Originally set up for manufacturing of Sodium Metal, the Company subsequently diversified into manufacturing of Sodium Derivatives, Pyridine Derivatives, Fine Chemicals and APIs etc. The Company is recognised as an “Export House” by DGFT and is also recognised by the Department of Science and Technology, New Delhi as an approved “In house R & D Facility”. The Company has three manufacturing units, at Uppal, Dommara Pochampally at Hyderabad and JNPC Visakhapatnam.

2. BASIS OF PREPARATION AND MEASUREMENT

2.1. Statement of Compliance

The financial statements for the year ended 31st March 2024 have been prepared in accordance with Indian Accounting Standards (“Ind AS”) prescribed under Section 133 of the Companies Act, read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant amendment rules issued thereafter.

2.2. Accounting Convention and Basis of Measurement

The financial statements have been prepared on the historical cost convention and on an accrual basis, except for the following material items that have been measured at fair value as required by relevant IndAS:

- a. Certain financial assets and liabilities measured at fair value (refer accounting policy on financial instruments)
- b. Defined benefit and other long-term employee benefits.

2.3. Functional and Presentation Currency

The financial statements are presented in Indian rupees, which is the functional currency of the Company and the currency of the primary economic environment in which the Company operates. All financial information presented in Indian rupees has been rounded off to the nearest lakh, except for number of shares and Earnings Per Share data.

2.4. Use of Judgements, Estimates and Assumptions

The preparation of the financial statements in conformity with Ind AS requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities at the date of the financial statements and reported amounts of revenues and expenses during the year and the disclosure of contingent liabilities and assets. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and in any future periods affected.

Information about critical judgements in applying accounting policies, as well as estimates and assumptions in respect of the following areas, that have most significant effect to the carrying amounts within the next financial year are included in the relevant notes.

- a. Useful lives of property, plant, equipment and intangibles
- b. Measurement of defined benefit obligations
- c. Measurement and likelihood of occurrence of provisions and contingencies
- d. Recognition of deferred tax assets/liabilities
- e. Impairment of intangibles
- f. Expenditure relating to research and development activities.



2.5. Operating Cycle

Based on the nature of products/ activities of the Company and the normal time between acquisition of assets and their realisation in cash or cash equivalents, the Company has determined its operating cycle as 12 months for the purpose of classification of its assets and liabilities as current and non-current.

3. SIGNIFICANT ACCOUNTING POLICIES

3.1. Property Plant and Equipment

- a. Property Plant and Equipment are measured at cost less accumulated depreciation and impairment losses.
- b. The cost of property, plant and equipment includes those incurred directly for the construction or acquisition of the asset, and directly attributable to bringing it to the location and condition necessary for it to be capable of operating in the manner intended by the management and includes the present value of expected cost for dismantling/ restoration wherever applicable.
- c. The cost of major spares is recognised in the carrying amount of the item of property, plant and equipment in accordance with the recognition criteria set out in the Standard. The carrying amount of the replaced part is derecognised at the time of actual replacement. The cost of the day-to-day servicing of the item are recognised in statement of profit and loss account.
- d. Depreciation on Property, Plant and Equipment is provided under straight line method over the useful life of the assets as specified in Part C of Schedule II to the Companies Act, 2013 and the manner specified therein. Assets costing less than ₹ 10,000 are fully depreciated in the year of purchase.
- e. Expenditure attributable / relating to PPE under construction / erection is accounted as below:
 - To the extent directly identifiable to any specific plant / unit, trail run expenditure net of revenue is included in the cost of property plant and equipment.
 - To the extent not directly identifiable to any specific plant / unit, it is kept under “expenditure during construction” for allocation to property plant and equipment and is grouped under capital work in progress.
 - Advances paid towards the acquisition of property, plant and equipment outstanding at each Balance Sheet date is classified as capital advances under other non-current assets.

3.2. Intangible Assets

- a. Intangible Assets are recognised when it is probable that future economic benefits that are attributable to the asset will flow to the enterprise and the cost of the asset can be measured reliably. Expenditure incurred for creating infrastructure facilities where the ownership does not rest with the Company and where the benefits from it accrue to the Company over a future period is also considered as Intangible Asset.
- b. New product development expenditure, software licenses, technical knowhow fee, infrastructure and logistic facilities etc., are recognised as Intangible Assets upon completion of development and commencement of commercial production.
- c. Intangible Assets are amortised on straight line method over their technically estimated useful life.
- d. Residual values and useful lives for all Intangible Assets are reviewed at each reporting date. Changes if any are accounted for as changes in accounting estimates.



3.3. Impairment of Asset

a. Financial Assets

The Company applies expected credit loss (ECL) model for measurement and recognition of impairment loss on the following financial assets and credit risk exposure:

- Financial assets that are debt instruments and are measured at amortised cost whether applicable for e.g. loans debt securities, deposits, and bank balances.
- Trade Receivables

The Company follows 'simplified approach' for recognition of impairment loss allowance on trade receivables which do not contain a significant financing component. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition.

b. Non – financial assets

The Company assesses at each reporting date whether there is any objective evidence that a non-financial asset or a group of non-financial assets is impaired. If any such indication exists, the Company estimates the amount of impairment loss.

3.4. Inventories

Items of inventories are valued at lower of cost or net realisable value after providing for obsolescence, if any. Cost of inventories comprises of cost of purchase, cost of conversion and other costs incurred in bringing them to their respective present location and condition. Cost of raw material is determined on FIFO method.

The factors that the Company considers in determining the provision for slow moving, obsolete and other non-saleable inventory include estimated shelf-life, ageing of inventory and to the extent each of these factors impact the Company's business and markets. The Company considers all these factors and adjusts the inventory provision to reflect its actual experience on a periodic basis.

3.5. Foreign Currency Transactions

- a. Transactions relating to non-monetary items and purchase and sale of goods /services denominated in foreign currency are recorded at the exchange rate prevailing or a rate that approximates the actual rate on the date of transaction.
- b. Assets and liabilities in the nature of monetary items denominated in foreign currencies are translated and restated at prevailing exchange rates as at the end of the reporting period.
- c. Exchange differences arising on account of settlement / conversion of foreign currency monetary items are recognised as expense or income in the period in which they arise.
- d. Foreign currency gains and losses are reported on a net basis.

3.6. Revenue Recognition

While recognizing the revenue under Ind AS-115, in respect of Contracts which meet the defined criteria, due consideration has been given to identify all the performance obligations stated therein including transfer of goods or services as well as term of payment. The transaction price is allocated to each distinct and identifiable performance obligation and is also adjusted for the time value of money. In respect of goods, revenue is recognised on transfer of significant risks and rewards of the ownership including effective control of the buyer. In respect of all other services/performance obligations, revenue is recognised upon of completion of such performance. The revenue so measured is stated net of trade discounts / rebated and other price allowances, wherever applicable. Other income including interest is recognised on accrual basis.



3.7. Government Grants:

The incentives received on Exports/Imports of Goods are deducted from the respective expense head on receipt basis.

3.8. Employee Benefits

a. Short term Benefits

All employee benefits falling due wholly within twelve months of rendering the service are classified as short-term employee benefits. The cost of the benefits like salaries, wages, medical, leave travel assistance, short term compensated absences, bonus, exgratia etc., are recognised as an expense in the period in which the employee renders the related service.

b. Post -employment benefits

• Defined Contribution Plans

The contribution paid /payable under provident fund scheme, ESI scheme, and employee pension scheme is recognised as expenditure in the period in which the employee renders the related service.

• Defined Benefit Plans

The Company's obligation towards gratuity is a defined benefit plan. The present value of the estimated future cash flows of the obligation under such plan is determined based on actuarial valuation using the projected unit credit method. Any difference between the interest income on plan asset and the return actually achieved and any changes in the liabilities over the year due to changes in actuarial assumptions or experienced adjustments within the plan are recognised immediately in other comprehensive income and subsequently not reclassified to the statement of profit and loss.

All defined benefit plans obligations are determined based on valuation as at the end of the reporting period, made by independent actuary using the projected unit credit method. The classification of the Company's net obligation into current and non-current is as per the actuarial valuation report.

c. Long term Employee Benefits

The obligation for long term employee benefits such as long-term compensated absences, is determined and recognised in the similar manner stated in the defined benefit plan.

3.9. Borrowing Cost

- a. Borrowing costs incurred for obtaining assets which take substantial period to get ready for their intended use are capitalised to the respective assets wherever the costs are directly attributable to such assets and in other cases by applying weighted average cost of borrowings to the expenditure on such assets.
- b. Other borrowing costs are treated as expense for the year.
- c. Significant transaction costs in respect of long-term borrowings are amortised over the tenor of respective loans using effective interest method.



3.10. Provision for Current Tax and Deferred Tax

a. Current Tax

The tax currently payable is based on taxable profit for the year. Taxable profits differ from the profit as reported in the statement of profit and loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted or substantially enacted by the end of the reporting period. In the event of Tax computed as stated is less than the tax computed under section 115JB of the Income tax Act., 1961, provision for current tax will be made in accordance with such provisions.

b. Deferred Tax

Deferred Tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred Tax liabilities are generally recognised for all taxable temporary differences. Deferred Tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised.

The carrying amount of Deferred Tax asset is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred Tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of Deferred Tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period to recover or settle the carrying amount of its assets and liabilities.

c. Current Tax and Deferred Tax for the year

Current and deferred tax are recognised in profit and loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Deferred Tax resulting from "timing difference" between taxable and accounting income is accounted for using the tax rates and laws that are enacted or substantively enacted as on the balance sheet date. Deferred Tax asset is recognised and carried forward only to the extent there is reasonably certain that there will be sufficient future income to recover such Deferred Tax Asset.

3.11. Minimum Alternate Tax Credit

Minimum Alternate Tax Credit Entitlement is recognized in the books of account when there is convincing evidence that the Company will pay normal income tax during the specified period. The Entitlement is reviewed at each balance sheet date with regard to the correctness of the carrying amount.

3.12. Research and Development

Capital expenditure incurred has been disclosed under separate heads of account and revenue expenditure incurred is charged off as a distinct item in the Statement of Profit and Loss.

**3.13. Financial Instruments (Financial Assets and Financial Liabilities):**

All Financial Instruments are recognized initially at fair value. The classification of Financial Instruments depends on the objective of the business model for which it is held and the contractual cash flows that are solely payments of principal and interest on the principal outstanding. For the purpose of subsequent measurement, Financial Instruments of the Company are classified into (a) Non-Derivate Financial Instruments and (b) Derivative Financial Instruments.

a. Non-Derivative Financial Instruments:

- Security Deposits, Cash and Cash Equivalents, Other Advances, Trade Receivables and Eligible Current and non-current financial assets are classified as financial assets under this clause.
- Loans and borrowings, trade and other payables including deposits collected from various parties and eligible current and non-current financial liabilities are classified as financial liabilities under this clause.
- Financial instruments are subsequently carried at amortized cost.
- Transaction costs that are attributable to the financial instruments recognized at amortized cost are included in the fair value of such instruments.

b. Derivative Financial Instruments:

- The policy in respect of Derivatives will be formulated as and when required.

3.14. Claims

Claims by and against the Company, including liquidated damages, are recognised on acceptance basis.

3.15. Leases:

The Company's lease asset classes primarily consist of leases for land and building. The Company assesses whether a contract contains a lease, at inception of a contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether: (i) the contract involves the use of an identified asset (ii) the Company avails itself substantially all of the economic benefits from use of the asset through the period of the lease and (iii) the Company has the right to direct the use of the asset. At the date of commencement of the lease, the Company recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short-term leases) and low value leases. For these short-term and low value leases, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

As a lessee, the Company determines the lease term as the non-cancellable period of a lease adjusted with any option to extend or terminate the lease, if the use of such option is reasonably certain.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. The lease liability is initially measured at amortized cost at the present value of the future lease payments. The lease payments are discounted using the interest rate implicit in the lease.

Lease liability and Right to Use assets have been separately presented in the Balance Sheet and lease payments have been classified as financing cash flows.

**C. Financial Risk Management****Financial Risk Factors :**

The Company is exposed to financial risks arising from its operations and the use of financial instruments. The key financial risks include market risk, and liquidity risk. The management reviews and design policies and procedures to minimize potential adverse effects on its financial performance. The primary market risk to the Company is foreign exchange risk. The Company's exposure to credit risk is influenced mainly by the customer repayments. The Company's exposure to liquidity risks are on account of interest rate risk on borrowings. The following sections provide details regarding the Company's exposure to the above-mentioned financial risks and the management thereof.

Market Risk:

The Company operates internationally, and a portion of the business is transacted in foreign currencies and consequently the Company is exposed to foreign exchange risk through its sales and services in those countries. The exchange rate between the rupee and foreign currencies has changed substantially in recent years and may fluctuate substantially in the future. Consequently, the results of the Company's operations are affected as the rupee appreciates/depreciates against these currencies. The Company leaves exchange rate risk with regard to foreign exposures unhedged when the local currency is appreciating against the foreign currency.

Credit Risk:

Credit risk is the risk of loss that may arise on outstanding financial instruments when counter party defaults on its obligations. The Company's exposure to credit risk arises primarily from loans extended, security deposits, balances with bankers and trade and other receivables. The Company minimises credit risk by dealing exclusively with high credit rating counterparties. The Company's objective is to seek continual revenue growth while minimising losses incurred due to increased credit risk exposure. The Company trades only with recognised and creditworthy third parties. It is the Company's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis with the result that the Company's exposure to bad debts is not significant.

Credit Risk Exposure:

At the end of the reporting period, the Company's maximum exposure to credit risk is represented by the carrying amount of each class of financial assets recognised in the statement of financial position. No other financial assets carry a significant exposure to credit risk.

**Liquidity Risk:**

The Company's principal sources of liquidity are cash and cash equivalents and the cash flow that is generated from operations. The Company has short term borrowings from banks. Short term loans repayable on demand from banks are obtained for the working capital requirements of the Company.

As of 31st March, 2024, the Company had a working capital of ₹ 717.17 Lakhs including cash and cash equivalents of ₹ 3.83 Lakhs. As of 31st March, 2023, the Company had a working capital of ₹ 606.02 Lakhs including cash and cash equivalents of ₹ 109.80 Lakhs.

As of 31st March, 2024, and 31st March, 2023, the outstanding gratuity liability was ₹ 307.63 Lakhs and ₹ 236.93 Lakhs, respectively, which have been substantially funded. Accordingly, no liquidity risk is perceived.

Interest Rate Risk:

The interest rate risk is the risk that the fair value or the future cash flows of the Company's financial instruments will fluctuate because of the change in market interest rates. The Company is exposed to interest rate risks as it has significant interest-bearing working capital loans from bank. Short term loans repayable on demand are subject to prevailing market rate fluctuations and sanctioned facilities are availed on a need to borrow basis to ensure minimum exposure to interest rate fluctuations.

43. DIVIDEND:

The final dividend on shares is recorded as a liability on the date of approval by the shareholders and interim dividends are recorded as a liability on the date of declaration by the Company's Board of Directors. Income Tax consequences of dividends on financial instruments classified as equity will be recognized according to where the entity originally recognized those past transactions or events that generated distributable profits. The Company declares and pays dividends in Indian rupees. Companies are required to pay/distribute dividend after deducting applicable withholding income taxes.

56. • During the financial year, the Company had transferred an Unclaimed Dividend amount of ₹ 0.64 lakhs (Final Dividend for FY 2015-16) and 3,951 shares of 48 shareholders to IEPF authorities. As per the procedure, the Company has transferred the Unclaimed Dividend to IEPF Authorities through NEFT and tried to link the NEFT challan but due to technical issue in the MCA portal, the challan is not getting linked thereby the e-Form IEPF-1 (*Statement of amounts credited to IEPF or transfer of amounts on account of shares transferred to the fund*) is not approved and the relevant excel file containing the breakup of Unclaimed Dividend is also not getting uploaded. As a result of this, the Company is also not able to file e-Form IEPF-4 (*Statement of shares transferred and information of shares & unclaimed or unpaid dividend not transferred to the IEPF*) and the relevant excel containing break up of Unclaimed Shares despite completing the transfer of shares to IEPF.
- The Unclaimed Dividend amount of ₹1.24 lakhs pertaining to Interim Dividend of FY 2015-16 which was originally transferred in February 2023 was also reversed and the said amount was parked in Suspense Account of the Bank. The Company was made aware of this fact only in the Month of February 2024 by the Bankers. The Company immediately requested the Bankers to transfer the funds from Suspense Account to IEPF Authorities Account and the same was transferred on 29th February, 2024. However, due to technical issue in the MCA portal, the Company is facing similar issue as stated above.
 - The Company is in continuous contact with the authorities and Bankers to resolve the issue at the earliest.
