3 BOULDERS REMOVED

Four boulders fall, block stairway to Mount Girnar

GOPAL KATESHIYA RAJKOT, AUGUST 2

FOUR BOULDERS skidded off Mount Girnar blocking the stairway to the famous Ambaji temple.

The incident happened early on Thursday after a week of heavy rain in the region that attracts hundreds of pilgrims every day. No injuries have been reported so far.

Authorities said they removed three of the four boulders by Friday, while efforts are on to remove the fourth.

"Technically, this is not a landslide. Some boulders became loose and rolled down from a nearby place in the aftermath of heavy rain. The incident happened in the early hours when no pilgrims were there," said Akshay Joshi, Deputy Conservator of Forests (DCF) of Junagadh territorial forest division.

Mount Girnar is Gujarat's tallest mountain and overlooks the Junagadh city by about 3,500 feet. The peak is accessible via a stairway of around 10,000 steps. The first 5,000 steps lead to the Ambaji temple.

The DCF said that the incident took place at around 2,100 steps up from the foothills, near the Cave of Bharthari. "Labourers could not remove the fourth boulder on Thursday as it is very large. Therefore, we decided to try and break it into pieces using

electric beakers," said Joshi, adding, "After the removal of the three boulders, people can now make their way, though the large boulder remains a hurdle."

Incidentally, Mount Girnar had experienced heavy rains in the week leading to July 24 and locals said that due to the continuous wet weather, the soil had become loose, causing the incident.

"The boulders had been there for ages on an elevated area a few metres from the stairway," said Vijay Trivedi, a Junagadh resident who is part of the team managing the day-to-day affairs of Ambaji temple. "In the past, we have seen small boulders rolling down the mountain and sometimes getting stuck on the stairway. But it is for the first time that boulders of such a large size have skidded off," he said.

In October 2020, Prime Minister Narendra Modi had inaugurated a ropeway that ferries people from Bhavnath Taleti, the foothills of Mount Girnar, to the Ambaji temple. "However, a majority of pilgrims use the stairway to climb up Mount Girnar," said Trivedi.

Aside from the temple for goddess Amba, Mount Girnar has several destinations for pilgrims, such as the peaks for Lord Dattatreya and Gorakhnath. The mountain is part of the Girnar Wildlife Sanctuary, which is one of the homes of the rare Asiatic lions.

Govt has woken up after TRP Game Zone fire, says High Court on new safety rules framed

THE GUJARAT High Court said on Friday that the state government has "woken up after the TRP Game Zone fire" in Rajkot, which had killed 27 people in May, and come up with the Gujarat **Amusement Rides and Gaming** Zone Activity Safety Rules, which were introduced by the state Home department in June.

As it orally directed the government to expedite the process of constituting a committee to implement the rules, Advocate General Kamal Trivedi told the bench of Chief Justice (CJ) Sunita Agarwal and Justice Pranav Trivedi that the government has drafted model rules for amusement and gaming zones and "supplied" the same to police commissionerates for drafting of local rules.

"The model rules have been put in the public domain and objections invited. Thereafter, they were supplied to each commissionerate to make local changes and shortly, each commissionerate will notify the rules locally." he added.

When Trivedi said that city ride safety and inspection committees would be constituted within a month after the rules are notified, the court said one month was "too much" of time to constitute such committees. It added that while two weeks would be needed to notify the rules and one week thereafter to constitute the committee and notify the same, a compliance report should then be sent to the Home secretary.

The court insisted that the government must create aware-

"They (government) have woken up after Rajkot (TRP Game Zone fire) only. The rules were supposed to be framed earlier but they have framed rules now... In the Rajkot game zone incident, license was granted by one police inspector only... Now, there is an authority... the collector or commissioner would be required to ensure that the authority should know what the rules are. They cannot claim ignorance...," it

The court insisted on "orientation" programmes for officers to make them aware of the new rules for gaming zones.

Meanwhile, addressing the issue of "vacant posts" in fire departments under various civic bodies, CJ Agarwal said that municipal corporations had issued advertisements in the media to fill vacant posts of chief fire officers "only after court hearings".

Seeking clarification on the selection process, the HC said, "Is there any recruitment rule for selecting fire officers if municipal commissioners are selecting chief fire officers... Only Ahmedabad city has a CFO, all other posts are vacant."

The HC pointed out that the advertisement for recruitment of chief fire officer (CFO) of Gandhinagar Municipal Corporation (GMC) was floated only after HC heard a matter related to it. When informed that all municipal commissioners have been directed to start the selection process and create a separate fire safety wing, it said, "All action has been initiated after court hearings... The GMC recruitment advertisement was issued on July 8... So, the principal secretary (Urban Development) is to supervise the process of filling up the vacancy."

The HC also directed the state government to ensure that the CFOs are given training after recruitment. "Is there training for new officers after recruitment... There has to be. Even for the highest officer," it said.

Trivedi, during his submission in the court, also read out a letter sent by Principal Secretary (Urban Development and Urban Housing) Ashwini Kumar to eight municipal commissioners, seeking compliance of the HC directions. Trivedi read out the letter, which emphasised that the onus was on the commissioners in case of negligence and inaction in matters concerning public lives.

The HC will hear the matter next on August 9.

Over 750 schools yet to be compliant with fire safety norms: Education dept

AS MANY as 771 schools in Gujarat are yet to comply with fire safety norms while another 1,117 schools have applied for either fresh or renewed fire No Objection Certificates (NOC), a report by the state education department submitted before the Gujarat High Court stated Friday.

According to the report, these 771 schools, including 578 primary and 193 secondary and higher secondary schools, are "in the process of getting fire compliant". These include 183 government schools, including 172 primary and 11 secondary.

The affidavit was submitted by Vinod Rao (former secretary education department) to the High Court on August 1 as part of the ongoing suo motu Public Interest Litigation over the Rajkot TRP Game Zone fire. It added that 3,345 teams were constituted for inspecting schools and getting the requisite data regarding fire safety measures.

The schools "have been earnestly requested to get the needful done in the matter as early as possible with the extension of assistance to them to procure valid fire NOC, so as to see that such schools are

equipped with the fire NOC at the earliest," the affidavit stated.

On July 24, the schools were given 30 days for getting or renewing the fire NOC. For now, gatherings in large numbers as well as use of pantry or kitchens have been barred within these school premises. The schools with ground plus two floors have been asked to use only ground plus one floor. In addition, they have been asked to function in two shifts — morning and afternoon. The schools have also been asked to undertake mock drills.

The affidavit added that Samagra Shiksha, a government programme for inclusive and equitable quality education to all children between four and 18 years, has issued work orders that would include construction of water tanks, installation of hose reels, and threephase electric connection. This would be completed within two months, the affidavit read.

According to the education department data, mock drills have been conducted by the Gujarat State Disaster Management Authority (GS-DMA) in 23,206 primary schools and 4,768 government grant-in-aid secondary and higher secondary schools, and 2,924 private secondary and higher secondary schools.
